## RULE CHANGES: (PREVIOUSLY FROM DECEMBER)

*Player/Coach Communication Equipment* (1-6-1; 1-6-2 and 3-2-5) and Umpire-In-Chief **may** forfeit the game for prescribed infractions by coaches, players, or bench personnel. Issues with spectators will be referred to site management personnel. (10-2-3h)

*Points of Emphasis:* Please be concerned and attentive to the following topics during the game:

**Malicious Contact:** Contact or a collision is considered to be malicious if (1) the contact is the result of intentional excessive force, and/or (2) there is intent to injure.

**Profanity:** There is no excuse for foul language, either direct or indirect, on the baseball field. Penalties will include: (1) verbal warning to offender; (2) written warning that warrants the restriction to the bench/dugout for the remainder of the game, or (3) eject the offender for a major offense.

**Pace of Play:** Baseball games can be more efficient with a focus on time and time management. Pace of play involves several factors that include: 20-second time limit between pitches; time between half-innings; batter repeatedly stepping out of the box, excessive player conferences, and umpire's time management skills.

**Cadet Class:** Training classes have started and (19) cadets are attending. Please urge anyone thinking about becoming an umpire to contact an Executive Board member or complete the on-line registration process at [sjumps.com](http://sjumps.com) Second year cadets are encouraged to attend as a refresher course.

# Assignor's Korner:

Training of the Cadets is under way. Now is the time for everyone to open the books and start familiarizing yourself with the rules and proper mechanics. Remember the test will open shortly.

This leads to my points below:


1. Know the rules and mechanics of the competition you are calling. We do more than one set of baseball rules. You are expected to use the rules and mechanics of the governing association. NFHS rules/mechanics are different than Pro.
2. Your focus is on the field of play, not the spectators. If you are having problems with spectators, let the onsite administration deal with it.
3. To the above, don't look for trouble, it will find you soon enough.
4. Call the game by the rules. Don't invent rules. While we may not like all of the rules we have to enforce, we cannot pick and choose.
5. De-escalate, use game management skills. Listen to the coach. If he is asking a question there is no harm in saying to him, "Coach, are you asking me if his foot was in the batter's box?" You can use your own words back to him/her so you both understand what is being requested. Once he/ she agrees that is what the request was, you can make your ruling. If a rule question, use rulebook terminology. Try to use a calming tone. You are the bastion of calm among the chaos. This is a very difficult thing to do.
6. If the coach asks you for help, you have a choice. You don't have to go. But consider the situation and play. Example, you are in the C position by the shortstop and the ball is hit towards you and the throw goes across the diamond. There is movement of the foot by the first baseman and you judge the runner out. The coach now questions your call. Would this be a "Stick with the play" or do you ask your partner if the foot was pulled.
7. Profanity by you as an umpire to a coach or a student is not a path we should walk. The scholastic field is also a classroom. It needs to be treated as such. We do not put up with it from the student or coach, they should not put up with it from us. That said, this is a reminder as it has not happened.
8. Remember, you are being watched. Everyone has a phone. What you do on field will be on the internet within hours.
9. Your only friend out there is your partner. Coaches are not your friends. Pregame at your car or locker room. Arrive on field together, inspect the field together, and leave together.
10. We all blow calls. Within that, if you think you have misinterpreted a rule, first point is to ask your partner, especially if the game is still on. Try to get it right. If this still bugs you, when you get home, look it up. You can also contact your crew chief and talk it over. Lastly, ask the association interpreter. We can also use this as a group learning opportunity as it can be brought up at an association meeting.
