## **REGULAR COUNCIL MEETING**

Mayor Ward called the regular council meeting to order at 6:00 p.m., September 6, 2022, at Hankinson Community Center. Council members present were Krump, Bladow, Heins and O'Hara. Roeder and Steffens were absent. Others present Grant Kuper, Bolton & Menk; Justin O'Hara, Richland County law enforcement; Mark Shaffer; Reggie Bladow, Nick Pohl and Angie Evans, City of Hankinson; Bob Wurl, Hankinson CDC; Beth Tiegs and Marlin Krump were also in attendance.

Motion by O'Hara/Krump to approve the August 1, 2022 regular meeting minutes. Carried.

Motion by Krump/Bladow to approve the August law enforcement report. Carried.

Bladow/Krump made a motion to approve the Municipal Judge's report for August. Carried.

Discussion was held regarding drainage, sanitary sewer and watermain and storm water retention for Reserve A subdivision. Motion was made by Bladow/O'Hara to approve Bolton & Menk Work Order #8 Professional Services Contract for Preliminary & Construction Engineering for Utility and Drainage Master Plan for Reserve A Subdivision (north of 6<sup>th</sup> Street SW, south of Canadian specific railway, and west of 168<sup>th</sup> Ave SE). Carried.

Schaffer and Justin O'Hara were present to request the purchase of city owned lots on parcels 48-1010-04720.000, 48-1010-04721.000, 48-1010-4723.000 and 48-1010-04725.000.

Krump offered Resolution 22-14 Sale of City Lot to Safe-T-Lock Storage LLC for \$10,000.00 with the stipulation building will commence within 1 year. Heins second. Krump, Bladow, Heins – yes. Council member O'Hara abstains. Carried.

Heins requested the option to hook-up to city water & sewer on property outside city limits. He is looking to purchase parcel 30-0000-05682.000 and build modular units for short-term housing. Infrastructure will be reviewed and other possible options to allow Heins to be connected to the city's water & sewer. This topic will be revisited once more information is available.

Tiegs and Marlin Krump discussed insurance coverage for Hankinson Community Center. After discussion of coverage of two different policies, Heins/O'Hara made a motion to switch coverage from North Star Mutual to ND Fire & Tornado fund. Tiegs is the City's local representative with NDFT. Coverage will begin effective 10-3-22 when the current policy is up for renewal. Tiegs will provide additional premium options & coverage for 112 Main Ave S. Carried.

A motion by Bladow/Krump to approve the auditor's August financial report. Carried.

Motion by Krump/O'Hara to accept the August 2022 bills for payment. Carried.

Krump/Heins made a motion to approve Freedom Comfort's annual preventative maintenance agreement for City Hall, City Shop, Hankinson Community Center, Kinn Building, and Library to perform checks on HVAC system and other equipment in the amount of \$2,600.00. Carried.

Motion was made by Bladow/Krump to sell city lots in the amount of \$3,250.00 to Oliver Hugaas, contingent on receiving plans, including site plan, foundation plan, truss drawings, elevations and floor plan, along with plumbing and HVAC system plans. Carried.

After discussion regarding the request to allow Richland County Wildlife Club Inc to provide guided bow hunting with youth on city's parcel 48-4000-03947.000, within the tree row on the southeast corner and erecting a deer stand, Krump/Bladow made a motion to approve an agreement to allow it. The agreement will be for a period of ten years. Carried.

Motion by Krump/Bladow to adjourn at 8:38 p.m. Carried.
