All other work has been completed for the 2018 year.

3F exhibit in report is a letter from Board members from Colonial Acres Phases 1-4 requesting phase 5 to pay a portion of the road repairs to the entrance of Colonial Acres on Pontiac Trail.

Snow removal company continues to arrive on site to Colonial Acres Phase 5 later in the day then contracted. We are working with contractor to get him on site earlier. The property has several members that are not moving cars in accordance with the rules and regulations. Those members are costing the property money as the snow-plows must wait or work around these vehicles or just not plow the whole section. page 8 Is Snow Is A Four Letter Word To You? By Denise Semion

This winter, it seems like there's been more complaints than ever about moving vehicles for snowplowing. Let's face it: We chose to live in a community where we must all work together to enable the snowplow workers to do their jobs. And we all pay for the increased cost caused when workers cannot clear snow because someone forgot to move his or her car. Or, didn't hear the horn. Or, were busy. Or, you name it. Instead of listing all the reasons why people couldn't, or wouldn't, move their vehicles in a timely manner, I'd like to explain what Bill and I do whenever we know snow is in the forecast.




