Independent Review

To whom it may concern,

A review of Lakewood Forest Civic Association Inc's (LFCA) financial reports has been conducted for the period of August 2018 - July 2019. The documents reviewed include yearly budget reports, monthly income and expense reports, monthly balance sheet reports, monthly bank statements, and supporting invoices / receipts. The objective of this review was to ensure that LFCA is using its association funding in a reasonable manner and to ensure that record keeping is compliant.

Molen and Associates is not independent verifying or certifying these financials as public accountants. However, after a review of the documents discussed above, there are no issues that we are aware of that require any necessary modifications. Everything looks reasonable and customary.
