LAW SIGNATURE SCHOOL CRITERIA

A Law Signature School is defined as a comprehensive program offering multiple elective and non-elective courses at each grade level, in a sequential manner, concentrating on aspects of the law and legal processes for students in grades 9-12. It is typically created by school district administrations to offer students the unique enrichment that a concentration of law-related education courses and experiences can provide.

SCHOOL PROFILE

A Law Signature School has a two and four year college preparatory program. It includes extracurricular activities such as mock trials and simulated congressional hearings, community service, participation in local Teen Court programs and educational field trips. It enlists law related education professionals (lawyers, law-enforcement professionals, judges, scholars, for example) from the community as human resources for in-class and out-of-class instruction. It articulates with local colleges and law schools. It is designed specifically to strengthen the confidence level, college preparatory skills and positive attitude necessary for the successful movement into the world of work, college and effective active citizenship.

GOALS

Cultivate certain attitudes, beliefs and values, such as a commitment to constitutional democracy, dedication to the ideal of justice in society, informed, active and responsible participation in civic life, respect for fundamental dignity and rights of humans and appreciation for legitimately resolving societal conflicts and differences.

Promote the understanding of the law to the extent that students are able to take legal studies/cases and relate them to current events and combine them with law concepts, job readiness and college preparatory skills.

Provide a means for young men and women to explore career options in the field of law.

Promote written and verbal communication skill development with the objective to increase students' effectiveness in expressing ideas accurately and creatively.

To engage in teaching strategies that enable students to identify fundamental values in conflict and emphasize the higher-level thinking skills required for students to grapple successfully with controversial issues.

Provide structured opportunity for students to offer services and skills to the local community.

MINIMAL REQUIREMENTS FOR CLASSIFICATION OF LAW SIGNATURE SCHOOLS

In addition to the minimum goal requirements provided by the Louisiana Board of Elementary and Secondary Education, Law Signature Schools must encourage students to meet higher standards.

Law Signatures Schools must provide course offerings which would allow students to complete a minimum of four semesters of law signature electives.

Law Signatures Schools must require specific hours of community service dedicated to Teen Court where available or other law related public assisted agencies, i.e. senior citizen centers, 4-H clubs, Special Olympics, Habitat for Humanity.
