Litter Hunt's High Caliber Cali SR753072/02 x Choco Julian Zip SR755222/08 The purchase price **\$600** for males or **\$700** females. **Buyer needs to send a \$200 deposit with this contract to insure choice of pup . Buyer needs to present balance of payment at time of purchase. Deposits will not be refunded, unless there are extenuating circumstances.**

Choice

The Breeder/Seller will reserve a pup for you in the order of receiving deposits based on preference for color, gender, etc.

Pick-up

Pups will be available for pick-up at seven weeks of age. Meeting part way or delivering within 75 miles may be possible if it can be worked out between buyer and breeder. Shipping by airfreight will be expenses that must taken care of by the buyer. Puppies should be picked up by 8 weeks of age. Should arrangements be made to pick up pups at a later time then reimbursement for extra shots, worming and food will be added on at a negotiated rate between buyer and seller.

Condition of Pup at Time of Delivery and Return Policy

Pup shall have its dewclaws removed. It will have its first set of shots and be wormed. The pup will have been socialized and introduced to feathers. All pups will receive a health certificate at their vet check prior to being released to the Buyer. The Buyer should have the pup examined within 72 hours by a veterinarian of their choice after they take possession. During this first 72 hour time period, the pup can be returned for full purchase price. After 72 hours, Buyer assumes all responsibility for the pup that is not covered by the Guarantee. All return costs shall be the responsibility of Buyer.

Hip and Eye Guarantee

The Breeder/Seller guarantees the pup against genetic problems that prevent the pup from being certified by the Orthopedic Foundation for Animals (OFA) or the Canine Eye Registration Foundation, Inc. (CERF). For the guarantee to apply the pup's hips must be X-rayed and submitted to OFA for certification by 28 months of age and the eyes must be tested and submitted to CERF by 12 months of age. The pup must not have been used for breeding prior to these certifications. This guarantee only applies to the original Buyer.

If the dog is diagnosed by a qualified veterinary ophthalmologist as having Progressive Retinal Atrophy (PRA) or diagnosed by OFA as being moderately or severely dysplastic on or before the respective time periods to qualify for a replacement or refund:

- a) The dog must be sterilized and a letter stating that dog has been sterilized sent to the Breeder/Seller by Buyer's veterinarian, or**
- b) The dog has to be euthanized and a letter stating the dog has been euthanized sent to Breeder/Seller by Buyer's veterinarian, and**
- c) The dog's registration certificate must be returned, signing the ownership of the dog back to Breeder/Seller.**

The Breeder/Seller has the option of refunding the Buyer's purchase price or replacement. Replacement will be a comparable breeding.

All genotypes are normal and no mutant alleles are present. Both Cali and Zip have OFA Certifications of Good for their hips.
