AARP CHAPTER 1917 General Membership Meeting January 10, 2019

President Bob McCluskey opened the meeting at 10:00 AM and led us in the Pledge of Allegiance. Bob then introduced our guest speaker(s) Ms. Kristin Heiser, newly elected Worcester Co. State's Attorney and Ms. Roberta Baldwin of the Worcester Co. Department of Social Services.

Ms. Heiser gave an overview of the State Attorney's office. The office handles criminal matters and has 10 offices. The office handles financial crimes against vulnerable adults. A new program, titled Veterans Treatment Court will prioritize treatments for veterans.

Ms. Baldwin gave an overview on the investigation of issues relating to older adults, including neglect, abuse, and financial mismanagement. Ninety-five percent of abuse comes from someone they know. If there is a problem the person must initiate contact by calling Maryland Access Point or the Department of Aging. They work in partnership with the Health Department.

MAC offers respite care but is limited to 10 hours per week. There is also an Adult Medical Day Care program available to provide daytime relief. The phone number for Social Services is 410-677-6806. Any concerns regarding scam phone calls should be reported to the Ocean City Police Department.

<u>Treasury:</u> The Treasury report was given by Sandy Kvech. Balances as of 12/31/18 are as follows: **General Funds - \$16,690.68; Scholarship - \$1,334.31; Health Fair - \$5,164.40; Travel - \$12,137.20** (NOTE - \$1,500 from Travel was provided as a subsidy for the holiday party)

The 2018 Holiday party totals are as follows: Income \$4,228.00; Expenses - \$4,055.62 resulting in a profit of \$172.38. There were 124 people in attendance. The subsidy from the Travel committee provided \$1,500 (\$600 for entertainment and \$900 for member cost subsidy and other related costs)

Our Chapter also made a \$300 donation to the Senior Center for the use of the facility this year.
