On the 2nd day of May, 2010 at 6 Suffern Place, Suffern, New York 10901, Under Article 10 of the Religious Corporations Law of NYS and pursuant to this Law, Iqra Darul Ehsan's Religious objectives and purposes were established to, conduct and maintain this House of worship in accordance with the Sunni, Hanafi traditions of the Islam and Deobandi faith and to conduct all communal affairs necessary for a viable community; to read the Quran and other religious works and teachings and to conduct religious services, prayers, rituals and ceremonies; to foster, advance and promote the practice of the Sunni Islam, Deobandi faith; to organize and conduct religious discussions among the members of this corporation and with other individuals and groups; to increase, foster and advance the understanding of religious principles, ideals and traditions and to create and establish programs to further such principles, ideals and traditions and generally to advance and promote the spiritual and physical welfare of the congregation and its members and to promote the religious, intellectual, moral and social welfare among its congregation. Rules and Regulations

Please read the following carefully:

**N.Y. PEN. LAW § 240.21 : NY Code - Section 240.21:
Disruption or disturbance of a religious service, funeral,
burial or memorial service.**

*A person is guilty of disruption or disturbance of a religious service, funeral, burial or memorial service when he or she makes unreasonable noise or disturbance while at a lawfully assembled religious service, funeral, burial or memorial service, or within one hundred feet thereof, with intent to cause annoyance or alarm or recklessly creating a risk thereof.
Disruption or disturbance of a religious service, funeral, burial or memorial service is a class A misdemeanor.*

Iqra Darul Ehsan has a NO TOLERANCE policy towards any person or persons, who may cause any kind of disturbance on its premises which may create an uncomfortable environment. Any sort of harassment; physical, verbal, stalking, aggravated harassment, menacing, reckless endangerment, disorderly conduct, criminal mischief, forcible touching, intimidation, threats including but not limited to mail, email, social media, telephone, voice mail, text or other electronic or any other means towards any members of the Board members, management, clergy staff, teaching staff, general staff, volunteers and any congregants.

Apart for being a Masjid (a place to perform obligatory or elective prayer services of Farz, Sunnas, Nawafil or Biyaans).

This is also a Madrassah (religious school) and all the protocols of a regular school is in-effect always.

This place is also a Sanctuary for Muslims practicing their religious service of reading the Quran or who chose to quietly practice Zikr (quiet meditation with Quranic verses).

Follow the Rules listed below to insure an appropriate atmosphere.

- **Masjid has a STRICT Dress Code Policy, anyone above the age of 7 will not be allowed in the Masjid in shorts or tank tops (calves and shoulders must not be exposed).**
- **NO Religious Sermons or ANY other kind of announcements or gatherings are to be given or held on Iqra Darul Ehsan's premises except by the QUALIFIED and AUTHORIZED individuals with the prior APPROVAL from the IDE Administrator.**
- **All Salat times will be determined and then indicated in the Salat Clocks, after the recommendation of the Imams and Mashwara with the Administration.**
- **DO NOT POST ANY SIGNS. All flyers or print or any kind of material is not allowed to be displayed, distributed without authorization of the Administration. Please silence your Cellphones or any other electronic devices upon entering these premises, and kindly ALWAYS refrain from any Loud or VAIN conversations, this disrupts Masjid's atmosphere.**
- **All children under the age of 10 years old must be accompanied by a Parent; our facility is NOT responsible in any way to look after them. Please make sure that you as a Parent insure their safety at all times.**
- **The Madrassa is completely OFF LIMITS during school hours except for AUTHORIZED PERSONAL. During off hours the access is allowed for Special Events ONLY. All requests for events, meetings, Lectures or gatherings, in the Masjid or the Madrassa must be done in writing, 30 days in advance to the Administrator.**

Legal action can be taken against any violators of the above policy.
