- ❖ As a member of East Valley Dive Club (EVDC), I understand that I am required to show respect to all teammates, coaches, parents, competitors, and facility workers at all times ____
- ❖ Practice BEGINS at the designated start time, I understand that I need to be ready to begin with the team in proper attire on time ____
- ❖ I understand that if I have my own means of communication (i.e. cell phone), I must send my coach notice of a missed practice as early as possible- at least 24 hours ahead of time is preferred when able; coaches can always be reached via text or email ____
- ❖ I understand that during practice hours, I am there to practice- any extreme delays in completing dives, workouts, excessive balking, or distracting teammates may result in my removal from practice ____
- ❖ Utilizing the classroom at any of our pools is a privilege, all equipment inside needs to be treated carefully. I understand that I need to do my part to pick up all my belongings at the end of practice and to not ring out towels or shammys on the carpet ____
- ❖ I understand that not abiding by these guidelines may result in removal from practice, groups, and in extreme cases, the team ____

Financial Policies and Procedures

I understand and agree that...

- ❖ Monthly payments are due no later than the 1st of every month (invoices are sent on the 25th of each month)
- ❖ Every member of EVDC must have current billing information on file, no exceptions
- ❖ All monthly payments will be automatically deducted on the 1st of each month unless I choose the cash/check option
 - Cash/Check payments must be made in 3 month increments (quarterly)
 - The full team fee of \$200 will be due at the beginning of the season, or at time of registration if you choose to pay this way
- ❖ There is a written 30 day notice of cancellation due in order to terminate membership with EVDC, there will be one final monthly payment due (divers on the competitive team will be required to pay out the remainder of their contract if terminating membership early)
- ❖ The \$200 team fee is due in two parts; \$100 in September (or at registration) and \$100 in April for each diver
- ❖ Intent to compete forms are due no later than one week prior to competitions, all families on the competitive team will be billed the coaches fee unless otherwise notified through the intent forms
- ❖ Practice begins at their stated start time, divers need to be inside and ready to BEGIN at the start time- we do all warm ups as a team
- ❖ Coaches should receive ample notice when a diver must miss a practice and can always be reached via email/text; a minimum of 24 hours is preferred when able
- ❖ Each family will be responsible for volunteering in at least one spot at any invitationals or events hosted by our team, any families who do not fulfill their volunteer spot will be billed an additional \$50 meet fee
