A. Consider and Discuss Ordinance No. 0-2017-14

D. Consider and Discuss Ordinance No. 0-2017-18

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CISCO, TEXAS, AMENDING CERTAIN SECTIONS OF CHAPTER 5 "ANIMALS AND FOWL" OF THE CITY'S CODE OF ORDINANCES; SPECIFICALLY SECTIONS 5-19 "REDEMPTION OF IMPOUNDED DOGS", SECTION 5-34 "CONFINEMENT FOR OBSERVATION", AND ADDING SECTION 5-23 "DOG SURRENDER FEE". (First Reading)

Animal Control Officer, Blake Pence, presented the Council with statistics for her department. She went on to discuss the purpose of the proposed changes to the ordinance. Councilmember Weger contended that he would like to see the surrender of animals be provided as a service to citizens free of charge. The Council as a whole agreed that there should be some safe guard to keep people from outside of the city from surrendering animals here for free such as presenting a current utility bill and photo identification. Councilmember Campbell suggested lowering the fee to \$10.00 and requiring presentation of a utility bill and identification.

A RESOLUTION OF THE CITY OF CISCO, TEXAS, EASTLAND COUNTY, AUTHORIZING AND ORDERING A SPECIAL MUNICIPAL ELECTION TO BE HELD ON JANUARY 30, 2018, FOR THE PURPOSE OF ELECTING MAYOR, BY THE QUALIFIED VOTERS OF THE CITY OF CISCO, TEXAS; APPOINTING ELECTION OFFICIALS; DESIGNATING THE POLLING PLACES; ESTABLISHING PAY RATES FOR ELECTION WORKERS; PROVIDING FOR NOTICE OF SAID ELECTION; PROVIDING FOR THE USE OF DIRECT RECORDING ELECTRONIC VOTING MACHINES; PROVIDING FOR EARLY VOTING; ESTABLISHING REGULAR BUSINESS HOURS OF THE CITY SECRETARY'S OFFICE ON THE EXTENDED TWO DAYS OF EARLY VOTING BY PERSONAL APPEARANCE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

F. Consider and Discuss Declaring Old Poly Tanks from the Water Treatment Plant as Surplus to be Sold.

Mr. Archer explained that there were 6 or 7 poly tanks at the Water Treatment Plant that will not be re-used in the new design. He would like to declare them as surplus and put them up for sale.

G. Consider and Discuss Annual Update of Employee Handbook.

Mr. Archer highlighted the proposed changes, most notably the change in allowing hourly employees to no longer accrue compensatory time. The Council discussed the merits of compensatory time versus overtime for those hourly employees required to work over the typical 40 hour work week. Mr. Archer explained that currently the city does not have a compensatory time policy even though some employees are granted compensatory time. He feels it would be overly burdensome to create and maintain that policy. The Council decided to table the Employee Handbook to look at adding a compensatory time policy. Other changes included new vacation policy for Fire Department employees, making all city vehicles and buildings smoke free, and adding employee birthday as a paid holiday.

No action was taken on this item.
