**Section 1. Legislative Intent**

It is the intent of this local law to RESCIND Local Law No. 2 of 2015 which overrode the limit on the amount of real property taxes that may be levied by the Town of COHOCTON pursuant to General Municipal Law 3-c, and allowed the Town of COHOCTON to adopt a budget for the fiscal year 2016 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law 3-c. In rescinding Local Law No. 2 of 2015, the Town of COHOCTON may certify that the 2016 budget will not exceed the tax cap and that no local law exists that overrides the tax cap, thereby ensuring the town is "tax freeze compliant."

**Section 2. Authority**

This local law is adopted pursuant to the authority under General Municipal Law, Municipal Home Rule Law and the doctrine of legislative equivalency, which authorizes the town board to rescind Local Law No. 2 of 2015 by the adoption of a new local law approved by vote of sixty percent (60%) of the town board.

**Section 3. Severability.**

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

**Section 4. Effective date.**

This local law shall take effect immediately upon filing with the Secretary of State.


