I/We acknowledge that if my/our child withdraws from this school year prior to the end of the term, the tuition deposit will not be refunded nor will it be applied to any outstanding amounts due. If for any reason it is necessary to withdraw my/our child from the Preschool, we agree to give at least thirty (30) days <u>written</u> notice or pay one month's tuition in lieu thereof. Returned check fee is \$25.00, plus any fees charged by the bank. After the second returned check, all payments must be paid in cash, cashier's check or money order. Any payment after the 15<sup>th</sup> of the month will be considered over due and will be subject to a late fee of \$25.00. If the current month's tuition has not been paid by the 1<sup>st</sup> of the month, your child cannot attend school until it is paid. After 60 days of nonpayment, a complaint will be filed with the Small Claims Court.

I/We, the undersigned parents/guardians of the above named student, agree to pay tuition and to comply with all the school policies as contained in the Parent's Handbook, as well as directives from the director's office while our child is attending Blessed Lambs Preschool. If I am in default in payment of monies owed to Blessed Lambs Preschool, and after a conference with the Director and Treasurer, I understand my child may be removed from the program. If my account is referred to an agency for collection, I agree to pay attorney's fees up to 25% of the principle amount due. The parties acknowledge that this is the entire agreement and that no modification can be made unless made in writing signed by all signatories to this original contract.
