- 1. To receive an update regarding Mirfield Tennis Courts (Cllr Bolt) Cllr Bolt and the Clerk confirm that there is no update - Defer
- 2. To receive an update regarding defibrillators (Cllr Guy & Clerk) Cllr Guy reports he has had contact with Elizabeth Higgins from Mirfield Rotary Club regarding partnership and reads the email. Clerk reports that the AED in the Community Centre is 8 yrs old and YAS recommend a new one. The cost for 2 AED's and 2 cabinets totals £3048 inc VAT, £48 above the budgeted cost. Cllr Guy **Proposed** the increased cost Cllr Burton **Seconded Vote: All in favour**
- 3. To receive an update regarding Neighbourhood Plan (Cllr Bolt) Cllr Bolt reports that 80% of the attendees of the meeting were in favour of a Neighbourhood Plan. Average cost £14k with possible grants. Cllr Bolt Proposed to take forward a Neighbourhood Plan Cllr Pinder Seconded Vote: All in favour Cllr Bolt Proposed £14k budget and for the group to facilitate an understanding to source available grants Cllr Pinder Seconded Vote: All in favour Cllrs agree the group should involve town councillors but the committee should be made up of residents and a meeting arranged with residents who expressed an interest.
- 4. To receive an update regarding Mirfield Matters Survey (Cllr Bolt & Clerk) No update keep on agenda
- To receive an update on Bradley Nurseries Closure & winter bedding plants for Town Centre (Cllr Taylor) – Cllrs discuss possible planting of herbaceous perennials outside council offices and Jenny Tomlinson Walsh confirms perennials are to be planted instead of annuals at Mirfield Library. Paul Blakeley reports Mirfield Rotary may fund flowers in Mirfield. Defer to next meeting.
- 6. To receive an update on Public Toilets (Cllr Pinder & Clerk) Cllr Pinder reports one of the urinals is blocked with a resin again. Clerk reports that the toilets are still being left open on an evening. Cllr Lees-Hamilton & Cllr Tolson agree to have a set off keys each and will liaise to close the toilets on an evening.

To consider arrangements for Flags/Standards for the High Street (Cllr Bolt) Cllr Bolt states that the receptacles for the Christmas Trees could support service flags for Army, Navy & Airforce that would enhance the High Street for events like Remembrance Parade and the proposed Freedom Parade.
