### # 1

**Unemployment** – above 8% for a record period of time. Unemployment would be over 9% if the statistics took into account the artificial improvements that are just due to people who have stopped looking for work, or those who are moving to disability benefits in record numbers. “Underemployment” is at record levels, and Obama hasn’t met with his jobs council for MONTHS! AND THIS JUST IN! The latest report from the Bureau of Labor Statistics, which shows the number of new jobless claims filed in the second week of September, indicates that the pace of layoffs in the United States is accelerating at the fastest pace since the 2007 recession!

🚫 # 28

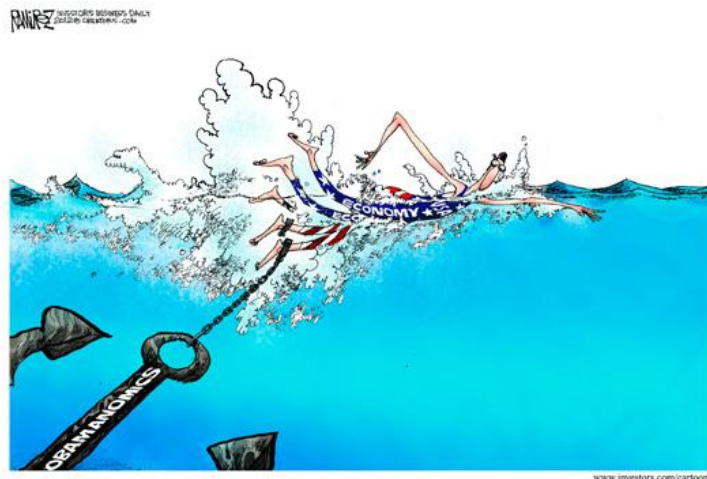
