DISCUSSION

- 1. DEPOT: The board discussed accepting the Long County Preservation Commission Ordinance. The board will be advertising for board members to serve on this committee.
- 2. PATRICIA JOHNSON/BOE: Mrs. Johnson stated in the paper Kierra Hamilton was referred to as superintendent, she is a supervisor, the board replied it was printed wrong in the paper. My paychecks have been late. I would like to report a tree needs to be removed on the Alma Flournoy Road; Mr. Blocker reported this is not on county property.
- 3. E-911: Mr. Blocker stated we are still working on this ordinance.
- 4. CHAIRMAN' REPORT: Mr. Long talked about moving back in the courthouse, working with the Development Authority, Bombing Range, Road Projects, E-911, Tourism for Long County, 301 Widening, and no appointments on any board until property taxes are paid and the Inmate Detail picked up 2000 pounds of trash on county roads.
- 5. RECREATION; Mr. Henry Strickland, Recreation Director presented a pond policy which I would like to post February 20, 2014, the board agreed for Mr. Strickland to post. I recommend the concession stand be operated by the 4-Hers.

- 6. TREAVOR SIKES: He discussed about roads in Millpond Subdivision to be conveyed to the county. The board stated we cannot accept these roads at this time. We need to have an engineer and the road superintendent to check the roads.
- 7. JOHN BRADLEY: Mr. Bradley discussed about metal signs, road for Angie Dukes Hill and Scott Stafford Phase III at Briarcrest, concerning to waive a letter of credit, we have to go by the ordinance.
