**IN 410 IAC 6-8.3 state rule** will consist of rule review for all who wish to become Inspector certified. **Everyone** will need to attend this day. (Previously we did not require certified installers to attend this day, but that is changing). **There will be a test over Rule 410 IAC 6-8.3 at the end of the day which is required to be passed (80%) in order to proceed with the course. Download a copy of the rule at [www.iowpa.org](http://www.iowpa.org). If the Day 1 test is not passed, the test will need to be retaken and passed prior to preceding to days 2 and 3 of the course.**

### **Day 2 – June 25, Training (earn 8 CEUs\*)**

**8 am to 6 pm**

Day 2 will be classroom training over system inspections.

### **Day 3 – June 26, Training/Exam (earn 8 CEU's)**

**8 am to 5 pm**

Day 3 will consist of 2 site visits in the morning and a test in the afternoon covering information presented during days 2 and 3.
