About the Event: On April 8th, 2024 North America will get it's second full solar eclipse in 100 years. This one is particularly special in that the time under total eclipse is almost twice as long as the 2016 Eclipse. Salem will see 3 minutes and 57.6 seconds of total eclipse, which is one of the longest in Arkansas and the nation as a whole.

WHAT: 2024 Total Eclipse Vendor Market

WHEN: Admission to the event is FREE to the public and will be held April 5-8

WHERE: Fulton County Fairgrounds, 124 Arena Lane, Salem AR 72576

WEATHER: NO REFUNDS because of weather.

VENDOR HOURS: Saturday, April 6th – 9am to 5pm; and Sunday, April 7th - 12 noon-4pm; If there is enough interest we will open on Monday, April 8th **Set up times: Friday 1:00 to 4:00 pm. On Friday, April 5th or Saturday morning at 8:00 am.**

PROHIBITED ITEMS: This is a family friendly event. The following items can NOT be displayed, sold or dispersed: Firearms, (knives are OK), pornography of any kind, controlled substances of any kind, drug related paraphernalia, and offensive and/or profane items. Prostitution and gambling of any kind are strictly prohibited. Eclipse committee has the authority to determine if a vendor has violated this policy, and if it is concluded this policy has been violated, the vendor will be removed for the remainder of the event without the refund of any of the vendor fee payment.

ELECTRICITY: \$10 Chg for electricity in Exhibit Bldg.

SALES TAX: Vendors will be responsible for collection and payment of all applicable state sales tax according to Arkansas law. If you have an Arkansas Sales Tax permit please attach to vendor application.

PARKING: All vendors MUST park in the designated vendor parking area.

VENDOR FEES:

The price is \$50 per 10' wide and 8' deep space. For multiple spaces, fees are \$75 for a double space and \$90 for a triple space. The vendor includes 1 table per space. Additional tables will rent for \$10 each. Tables will be either 6 ft or 8 ft.

DEPOSITS AND REFUNDS: **Absolutely no Refunds because of Weather!** A deposit of \$25 will hold your space until March 1, 2024. All fees are due no later than March 10, 2023. We have a limited number of spaces so we suggest you reserve your space now. **Vendor space will be rented on a first-come first-serve basis.** Vendor fees can be paid by cash, check, or debit/credit card. Follow the link on our website to pay online.

SET-UP AND TEAR DOWN FOR VENDORS: All vendors will be responsible for set-up and tear-down of their own displays. You must be set up by 9:00 am on Saturday, April 6th, with all vehicles moved to designated vendor parking by 9:30 a.m. You are welcome to cover and leave your items overnight. The building is secure and has cameras.

TEAR DOWN: Absolutely no vendor will be allowed to tear down before 3:00 pm on Sunday or you can tear down on Monday morning after 9:00 am. This is for safety purposes. Please break down your area before bringing your vehicle to the door to load.

TRASH: Trash cans will be provided throughout the event. Each vendor will be responsible for their own trash. Each vendor must collapse all boxes and dispose of their trash in dumpsters provided.

REMINDER: The Eclipse committee members reserve the right to refuse (prior to) OR remove during the event any vendor whose products, intentions, or attitudes are not compatible with the family-oriented nature of the event. Offensive merchandise will result in vendor(s) being removed from the event without refunds. **Please discuss any questionable items in advance.**
