This originally was going to cost the city \$55,000 to have done in 2021. April 2022 we got the grant Over time, price increased about \$40,000. After talking to engineer, we will get same bidders and could be higher. We have money in capital improvements. Suggests board approve bid. Afraid if we don't start the Phase One, we won't do two or three. Board members aware of money. Worse case would be \$97,000 out of the cities pocket.

EMERGENCY MANAGEMENT

Lord – General update on grant. Thanks Kris and Mark. He has asked a lot from them. They put some hours in, especially Mark. The grant right now is payroll only. It's a little over \$4,000. They have tried to submit all expenses and been asked to stop trying. Failed to submit quarter one, SEMA says we didn't, Kris says she submitted it. Not sure where the truth lies. Got \$0.00 for quarter one. For Quarter 2 Mark went as far back as we could, got half of October and the rest of Quarter 2. Got all for Quarter 3 and expects to get all of Quarter 4. He takes responsibility for this. Only submitting payroll.

Sirens – Bone out there for a few hours today. Everything was good. Was a siren on Delania stuck from wind and two others with insect problems. No expenses related to sirens right now but in the coming years, we will have. Battery will need to be replaced on one.

Storm – April 1st. Kris and Mark did an outstanding job. Mark worked with school to text everyone about FEMA building. Kris was all over social media. 300-400 people there. Good communication went well.

Training – Mark has completed 100%. Kris has two training courses left to complete by July. Heard Mark will have to step down as assistant. Lord asks attorney about Mark having to step down.

We are in compliance with the grant. On track. Just \$4000 this year and that's all we can get.

POLICE DEPARTMENT

Chief Howell – Conducted some interviews, about 5 in the last week. Only has one good candidate. Asks board to revisit the pay to get it passed tonight so we can get some qualified candidates. Icenhower says that they all had a chance to look at it. The reserve Sgt pay should be \$23.50. Icenhower asks if we are changing the Sgt pay too which will be \$25.50, and officers will be \$23. Pin Day, Up 2% every 2 years, \$0.50 shift differential. Voorhis asks what we are currently at. Chief says \$21 for officer and \$23.50 for Sgt is the current rate.

Motion by Icenhower to approve Chief's recommendation on police pay and incentives. Seconded by Veach.

Danderson isn't sure about the 2%. Is it something they will get above and beyond what the board gives them. Chief says that is longevity pay. Danderson has no problem with the pay raise and thinks the 2% should be a budget item.

Lord asks for Chief to read what the pay increase is. Danderson says they have been increased substantially since 2020. Danderson doesn't see this board not giving raises on a yearly basis. Guesses we raised it \$7 to \$8. Chief says a lot of departments have \$400 for insurance, we have \$900, We are trying to get people who have families.

Danderson says that this happened before. They had a pay scale and so much per year. When boards changed, that went away. At budget meetings they weren't adhering to their own scale and it was over. Unless you have the same people sitting here the whole time.

Lord says these officers will sign a compensation agreement.

Danderson says any board can get rid of whatever they want. Roe says that pay increase was taken away from them. Danderson has the most knowledge about our budget. Roe agrees with Danderson about another board undoing what they have done.

Icenhower says the 2% doesn't scare him. In June when the budget is set, instead of giving a large raise just give them a smaller raise and just expect 2%. Lord says it's an incentive to retain officers.

Stewart asks if everyone makes the same. Its step pay, it's longevity. If you decide to give a raise, it doesn't give more to the person who has been here the longest. This separates them and makes them want to stay. Chief appreciates Danderson's point of view. Chief says we have no one.

Stewart asks to see proposal. Chief explains it to him. Take home cars part of it. Pin day, bump in pay, shift differential (you miss a lot of stuff working nights)

Danderson asks if they will rotate. They will not. Will have day shift and night shift by seniority.

Stewart asks if it will help us recruit more people. Chief says that it will.

Icenhower says it will not be a problem this year. Danderson says there isn't much money in the general fund. Last he knew was \$59,000. All these figures you see on this form, that's what is the general fund. We can shift money from capital improvements but general has to pay it back. We aren't coming in loaded to this budget.

Chief says that that some of the issues of the cars. Someone blatantly removed SD cards out of the cars. They have video on them. No one should have had access to them. He found one in his office but has not been able to look at it. Someone yanked a cable out of the camera on the car. He is the only person to have access to the cameras. The proposal to fix our cameras and storage issues. No ability to store videos and separate police from city network. Rough estimates is \$16,000.

Danderson asks if they are different numbers. Chief says that he needs all three of those things approved.

Icenhower asks if he found the radio.

Danderson asks if this is our computer company. Previous officers was storing evidence files on their laptops. That cannot be done and should never be done. He has found some things that should have never been done. Some people should have had some severe consequences. The mapping system on the MDT's were removed. The MDTs get CAD by Greene County. It's what they look at for their calls. The mapping system is also installed. It shows where your calls are. The computers were left open and everyone had access to it. Every single MDT except the Chief's had the mapping systems removed. He can look at that mapping system and see where the officers made stops at. With that deleted, you can't even see that there was a stop. We have Child Advocacy items on the MDT's. That is evidence, and anyone can access them at this point. Not in a special file. He has found a lot of things around here. Was one gun short and by afternoon he was one gun long. Found the lost gun and it will be returned. The last inventory for the department was done in 2020 2021. Everyday it's an easter egg hunt about what he will find out today.

Ault asks if it's a normal gun or a different gun. When she was on the board, something similar happened. No accountability for guns since county came in before. Still working on the weapons. Had one missing out of evidence at one point and has not accounted for it yet. Will do his best to find it. People who were in place here and the things that have happened. Would like to fix the problems in our cars.

There are mounts for Ford's and they need special mounts for the system to work. Will give us 8TB of storage. 100,000 books = 1TB. Will give time to review and delete what we can in a state statute compliance manner. Locking computer up. The computer was stored in the officers room. Anyone could get on it and manipulate those files and delete anything. Hopes that no one would do anything nefarious. Icenhower says that we had one deleted that they know of.

Danderson asks if it's a proprietary bid. Chief says yes. You can't get this done anywhere else.

Chief says that Provision has the equipment and NRoute will help Altec out.

Lord says that we know there are problems and the Chief is trying to fix these problems. You have interviews with kids and body cam that anyone has access to. The SD cards allow them to record traffic stops. We are behind the times and we are playing catch up and it's expensive. Knows PD is spending money on vehicles and equipment and salaries. We aren't looking for a blank check.

Danderson wants to make it clear that this is not the first time that the board has seen this bid.

Still looking at some grants. Chief hands out papers to board. Other company did not get the quote. Hoped to have it today. We have a solar radar unit in the city off of Orchard and Main at the school. We had two, a battery operated one and solar one. The solar one outlasted the battery one. We get complaints on certain places in the city. We have put poles up for the portal one. Cottonwood, Willow, Main are our three major complaint areas, Maple is in there and has a different way to handle that. Getting these signs will keep honest people honest. Has a quote from the company that we have one from. Constantly having to change the batteries. Was hoping to have three quotes.

\$11,000 \$9,000

Bids. Hopes to get a grant before they make a decision. Will help reduce speed.

Streets are very narrow, most are 25mph, can't get a cop car turned in someone's driveway to help slow people down. Had handheld radar. No longer functioning. Lasted maybe 12 years. If he can't get a grant, he would like it in the budget.

Yield sign at Main and Orchard would like for it to be a stop sign. People don't stop or yield. Seen a lot of close calls. Danderson says you will have to get with Sara or Chan to get an Ordinance done.

Sewer Committee Report, April 23, 2024 (Updated)

A by-pass diesel powered pump was rented from March 19 to March 28 for the sludge return station at the WWTP. This was rented from Cogent who we had rented from before. This was done as an emergency decision at a cost of \$2,395.00. A rebuilt Pump from Independent Electric was delivered on March 25 to the WWTP Sludge Return Station and installed on March 28.

Also on March 28 we had 2 people from Fluid Equipment do service work on the Control Panel at Hwy CC lift station and one pump was pulled from the wet well and inspected. The impellor was found worn and the pump was taken back to their KC shop for inspection. They also picked up a second pump from the WWTP which had been pulled out of the Sludge Return Station due to a possible bearing noise. This pump will be torn down for inspection also. Lastly on March 28 Independent Electric picked up the backflow valve from the WWTP Influent Lift Station that had a broken spring to be replaced.

On April 5 a review meeting was held with Jason Roberts from Fluid Equipment, Kenny, Richard and myself. The Homa pump inspected from the Hwy CC wet well had wear on the impellor-believed to be from the heavy grease found in the bottom of the wet well. This pump will be inspected further at the Fluid Equipment KC shop. Jason recommended that we consider using a Fogrod (~\$1200) to replace the transducer that's anchored to the bottom of the wet well. The Fogrod monitor's the waste water level for turning pumps on/off and does a better job than the transducer anchored to the bottom. The Fogrod has to be cleaned weekly-easy to do. City of Nixa uses these in their lift stations. Also Jason recommended adding a flushing valve attached to the bottom of the pumps for Hwy CC Lift Station wet well. When the pump kicks on the flushing valve opens for 20-50 seconds to mix the grease in the wet well before pumping the waste water (~\$2000). We also discussed the failure of the first Homa pump removed from the WWTP-Sludge Return Station, it is likely that some solids were getting over the screens in the Sludge Return Station pit and into the impellor of the pump causing damage. The bearing failure led to the pump electric motor failing by allowing the rotor to come into contact with the windings and shorting the motor out. This pump cannot be repaired. We are still negotiating on how to move forward with this pump replacement.

On April 10, Reeds Plumbing from Springfield brought in a pump truck to the Highway CC lift station and pumped out the overflow tank and cleaned it. Reeds Plumbing is our City plumbing contractor this fiscal year. This invoice was \$2100.00

A meeting was held recently with Representatives from Copperstate Machine and Industrial from Queen Creek, Arizona to review issues that we are having with the bearings/gearbox/electric motor belt drive system on the 2 Rotor shafts in the Oxidation ditch. They also do repair work on Clarifiers. We need to get a bearing replaced on the vertical shaft of one of our Clarifiers. They have done all this type of work for the WWTP in Mt Vernon, MO. We are planning to reach out to some other suppliers next.

Lastly, one of the sand filters at the WWTP has been repaired and is working again.
