

LAKE GEORGE OPEN WATER SWIM

On Saturday, August 21, 2021, Hague once again hosted the Lake George Open Water Swim. There were 360 total registrants, representing 26 states and three countries/areas (US, UK, and Guam). There is normally a large contingent from Canada, but the border restrictions prevented that this year.

Safety coverage was great as there were around 23 safety kayakers and seven to eight safety motorboats.

With 33% of the surveys back, the participants rated the event a 4.91 of 5 overall. Ninety-nine percent said they would return next year and many said they will bring others. The one percent said no only because they will not be in the area at that time.

About one hundred and twenty of the participants spent the night in the Town of Hague and many others stayed in other locations nearby, as Hague was totally booked. Of those who stayed local, 22% stayed one night, 27% stayed two nights, and six percent stayed three or more nights, so this event was clearly a boon to Hague economically.

On August 20, 2022, the Lake George Open Water Swim will return to Hague with the 2.5k and 5k distances again, and the 10k will be the US Masters Swimming National Championship.

TRANSFER STATION MEETING AUGUST 30, 2021

The August 30, 2021, Town Board informational meeting on potential changes at the Hague Transfer Station attracted a large number of participants, both at the community center and on Zoom. Supervisor Edna Frasier thanked Board Member Steve Ramant for the work he has done on this issue and turned the meeting over to him.

Ramant reported that the transfer station revenue this year to date is \$39,416.77 and expenses to date are \$58,169.24, resulting in a loss to the town of \$18,752.47. He said this is not sustainable and that the town is considering making changes.

His suggestion is to have patrons enter where the current exit is, stopping next to the trash compactor. There, an employee would look at what people are dropping off and tell them what they owe. After paying, they would put their trash bag(s) in the compactor and move on to a recycling area, where there will be different containers for different types of recycled items like paper, glass, cans, and cardboard. Patrons would then exit on the road that is currently the entrance. Ramant noted that there will be large, highly visible signs and price sheets. Since the town pays by weight to have the compacted trash carted away, it looked into buying a scale to weigh each bag of trash. However, the town feels that the cost of the scales is too high and weighing each bag would be too time-consuming.

LGA WATER QUALITY REPORTING TOOL

If you you're on or near the lake or its tributaries and see something of concern like sediment or contaminants flowing into streams, an invasive species, soil erosion, or excessive land clearing, you can use the LGA's Reporting Tool at LGReport.org to document your exact location, attach photos, and provide any other details you think might be helpful to the Lake George Association (LGA). They'll review your report and determine the best course of action.

There's also a direct link to the New York State Department of Environmental Conservation Suspicious Algal Bloom Report Form in the event you see something that might be a Harmful Algal Bloom (HAB).

TRANSFER STATION MEETING, CONTINUED

Participants received a handout showing the current pricing and what items could be recycled. Several people asked questions and made suggestions. It was noted that some items such as paper were not listed on the handout. Ramant said the handout would be updated and put on the town website. When we went to press, it had not yet been posted.

Several people commented that moving the entrance would make it difficult for drivers in the winter. One individual suggested the town sell the scrap metal rather than paying to dispose of it. In past years, the town did sell it. However, Ramant said, he was unable to find a vendor within a reasonable distance. Another person suggested having an exchange site for items that people don't want. Frasier said this was also done in the past, but the town stopped because people dropped off junk. Other suggestions from the audience included raising the price for trash by a modest amount, having two employees instead of one, and having Sunday hours.

Several people asked what it would cost in taxes for the town to offer trash pickup. Some suggested doing a survey to find out whether people would want this and/or how they feel about raising the prices at the transfer station. Board Member Josh Patchett said that the town has a large reserve of funds and should not even consider shutting down the transfer station.

Pat Hintze, representing the Hague Seniors, said she doesn't want anyone to have to drive to Ticonderoga to drop off trash, especially in the winter. Frasier said the town does not intend to close the transfer station at this point and that would only be a last resort.

ZONING BOARD OF APPEALS - 8/26/2021

Chairman Robert Goetsch and Board Members Jon Hanna, Maureen Cherubini, Linda Mury, and Ray Snyder were present.

Dill (60.13-1-13) 67 Red Fox Lane (TR-1)

The applicant is seeking to replace an existing timber deck and a timber seawall with stairs with a permeable paver patio and a new natural boulder seawall with stairs. The permeable paver patio will be under 400 sq. ft. or approximately half the size of the existing timber deck. The seawall is approximately 230 feet long and four feet high. The new wall dimensions would be similar. Native plantings would be placed along the seawall. The application was deemed complete. A site visit was scheduled and a public hearing will be held at the next zoning board meeting on September 23, 2021.

PLANNING BOARD - 9/01/2021

Chairman Dick Frasier, Board Members Judy Gourley, Meg Haskell, and Pam Peterson were present, Martin Fitzgerald, Sr. was absent.

LUEDDEKE ((10-1-25.1) 164 New Hague Road (OCII)

The applicant is seeking to subdivide a 60.98-acre parcel into two lots of 52.98 and eight acres. A public hearing was held and no one spoke for or against. The application was unanimously approved with no conditions.

DILL (60.13-1-13) 67 Red Fox Lane (TR-1)

The applicant is seeking to replace existing timber seawall with stairs and a timber deck with a new natural boulder seawall with stairs and a permeable paver patio with native plantings. A site visit was scheduled for September 9, 2021. The meeting was left open until after this site visit to allow the board to make a referral to the Zoning Board of Appeals. After the site visit, the planning board made a positive recommendation to the ZBA with the condition that it conforms to the specifications as written.

ROBINS (93.12-1-9.11) 7942 Lakeshore Drive (TR-1)

The applicant is seeking to replace an existing 845 sq. ft. patio with a permeable 880 sq. ft. natural stone patio and walkways with natural boulder fire pit within 100 feet of the Mean High-Water mark (MHWM). Steps to the patio will be replaced in kind. The patio will not be within the 50-foot setback from the MHWM. The application was unanimously approved.

PARLIN-JOYCE (60.13-1-22) 24 Pudding Lane (TR-1)

The applicant is seeking to demolish a home and construct a new home. The project includes a waste water treatment system and storm water management. The storm water permit has been approved by the Lake George Park Commission. The waste water treatment is a Puraflo Peat Fiber Biofilter system. The application was unanimously approved, with conditions that the homeowners sign a memorandum of understanding that they will have the required bi-annual inspections and maintenance specified by the manufacturer of the waste water system performed and that documentation will be provided to the Hague Zoning Enforcement Officer.

MILLER-ZIER (26.6-1-22) 5 Forest Bay Road South (TR-1R)

The applicant is seeking to add a full second floor and 150-square-foot addition with stairs to the first floor of the existing residence. The existing structure is greater than 50 feet from the MHWM. The application was unanimously approved.

TOWN BOARD - 9/14/2021

The Hague Chronicle did not have any personnel available to attend and report on the September 14th town board meeting. As a totally volunteer organization, many of whom are seasonal residents of Hague, attending local events and taking notes (and often photos) on a year-round basis is an ongoing dilemma. WATER QUALITY MATTERS



The wheels of progress are starting to pick up speed! There were a couple recent activities of note regarding septic systems, their impact on the lake's water quality, and the possibility of future regu

possibility of future regulations for mandatory system inspections.

On September 2, 2021, the Lake George Park Commission (LGPC) held its third monthly Ad Hoc Septic Systems Committee meeting (video recording and minutes at www.lgpc.ny.gov .The committee is chaired by Ken Parker of the LGPC and includes a long list of people from the LGPC, New York Department of Environmental Conservation (NYDEC), New York Department of Health (NYDOH), Lake George Association (LGA), LG Waterkeeper Chris Navitsky, The Chazen Companies, and representatives of the towns and general public from around the Lake George basin.

Supervisors from around the lake (including Hague) passed a resolution

requesting that the LGPC take the necessary steps to develop the framework for a lakewide septic inspection program. The committee has put together a list of other lake basin regulations from around New York State (NYS) including Keuka, Canandaigua, Cayuga, Otsego, and Honeyoye Lakes. Some of these have mandatory septic inspection programs that have been in existence for over twenty years. Several municipalities in the New York City watershed have also enacted regulations based on the protection of their drinking water supply. The next committee meeting will be held on October 7th. Stay tuned for details.

On August 10th, the property owners of Silver Bay hosted a meeting at Morse Hall titled "Waste Not, Want Not: Septic Systems and Changing Regulations." The 50 - 60 people in attendance heard Chris Navitsky's presentation "On-site Wastewater Treatment System Management in the Lake George Basin." Chris reviewed a lot of information covering the history of previous efforts to regulate septic systems and current ordinances in place in the Towns of Queensbury and Bolton based on property transfer. He covered the science relating to studies in the South Basin, which linked near-shore algae problems with poorly-performing septic

systems. In Queensbury, of the 122 property transfers so far, 80% needed septic system repairs or replacement. Extrapolating that to the 6,000 septic systems in the basin, 4,900 probably need work.

At the end of the presentation, Chris fielded about two dozen questions from the audience. Of major concern were: the cost of septic system replacement and the funding available to property owners; who would do inspections and their costs; the effect of rain, birds, and caterpillars on the algae problem; the length of time it takes to get septic systems approved in the Town of Hague and associated staffing issues; how to address water softener backwash and garbage disposal use; and whether mandatory inspections will be required.

There are still a lot of open questions, which will be answered as the LGPC, LGA, NYDEC, and others continue to gather data on a unified basin-wide plan for on-site waste water treatment system management.

LOOKING BACK

LAKE LORE

My great-great grandfather, Captain Robert H. Robinson, a sea captain living on Staten Island, took a Centennial Tour in 1876 and included

Lake George and Hague on his itinerary. A short time later, he purchased a small parcel of land just south of the Hague Steamer Dock from the Newton family and had a camp constructed on the shoreline as a retreat for relaxation from his voyages. At some point, it became known as "The Last House" (TLH).

My grandmother, Sarah Gertrude Robinson, born circa 1880, is said to have spent summers with her grandparents at the camp. In 1896, she purchased the farmhouse to the south, which she called "IdleRest" with money she had earned looking after her grandparents. That farmhouse was thought to have dated back to the 1850's.

She married Charles Henderson about a decade later and they raised four sons (Charles Jr., James William, Robert McDonald, and Donald LaForge) in Staten Island and Philadelphia with summers spent at IdleRest. At some point, the land between the house and the Day Boatyard (later Alexanders and then Lake Forest), which was wetland, was filled in by dredging from the lake.

In the late 1920's, my grandfather struck a deal with the Lyman family, who were frequent renters of the TLH and wanted a lakefront cottage. The deal was that the family would construct a house to HIS specifications and occupy it rent-free for ten years. "The Other House" (TOH) was constructed and the deal lasted the ten

constructed and the deal lasted the ten years.

My grandfather was an avid tennis player and he constructed a raised clay tennis court behind TOH. Agnes Hull rented and occupied the cottage for many years. My grandfather passed away in 1951 at Moses Ludington Hospital in Ticonderoga following a heart attack.

In the late 1950's, Bea Frasier lived in the TLH. Ten or fifteen years later, the cottage was sold to the Geyers, who in 1987, sold it to the McDonoughs, who still own it today.

My grandmother passed away on the porch of IdleRest in 1964, leaving my father and my Uncle Jim as surviving

owners of IdleRest and TOH. Uncle Jim passed in 1971, leaving my father as the sole owner.

In 1974, my parents decided to replace the old sheds on the south end of IdleRest with a new addition. The addition, raising a dormer in the old bathroom (now the loft), stripping the kitchen to the studs, and placing a block foundation was completed by Ticonderoga builder Dave Woods. Several years later, my dad sold TOH to a

gentleman from Arizona, who later sold it to the Pucketts, who continue to own it.

My father passed in 1994 and my twin brother, Jim, and I owned it until Jim passed in 2018. We have shared some great times and lots of laughs while enjoying and lovingly caring for IdleRest.

For years, we asked my father to either write or record the hundreds of stories he had so often shared about family, his experiences, and his love of Hague and Lake George. Some of these included: the fact that he was born the same year the steamer Mohican II was christened; the histories of many of the lake's steamboats, including the grounding of the Sagamore; the early rowing and swimming regattas; the development of Star Class sailboat racing; the Rogers Rock Yacht Club; the string quartet in which he played cello at the Rogers Rock Windmill; and the chartering of Northern Lake George Yacht Club. Sadly, he never took on the project of writing them down or recording them. So, with the isolation caused by COVID-19, I have begun writing "Lake Lore," my recollection of the good times that my family shared in Hague and at IdleRest.

Over my almost seventy-five years, I have met and interacted with many community members, as did my father and brother. I list, in no particular order, family names of those I can recall and suggest they undertake documenting their own family's "Lake Lore" before their stories fade from memory: Corscaden, Beaty, Rowan, Van Sickle, Bryant, Scott, Rottier, Bliss, R. Henry, J. Henry, Engler, Brock, Crabb, Strauss, Turner, Bolton, Cobb, Hoyt, Grimes, DeLarm, King, DeGraff, Smith, Ross, Brown, Mayer, Earl, Singer, Cook, Meislahn, Reynolds, Belden, Fraiser, Fitzgerald, Craig, Carpenter, Clifton, Laundree, McDonough, and Puckett.
