Trustee Trone made a motion to pay bills as presented with a second from Vaskie, motion carried.

COMMUNICATIONS

- -NCICG letter explaining grants, projects, etc.
- -PC Community Center donation request no action at this time
- -Bliss McKnight insurance bill was presented to the board in the amount of \$11,092.00. Trone made a motion to pay with a second coming from Haar, motion carried.

GUESTS

-Peggy Smith from the library informed the board that during the car show in September she would like to have a petty zoo in the park and then a Movie In the Park at dusk.

ZONING AND PLANNING

-Sandberg announced that we are still looking for a Zoning Officer.

WATER AND MAINTENANCE

-VP Sandberg was able to collect more surveys for NCICG for the possibility of applying for CDAP grants.

-Filter at the pump at the pump house went down - Grasser's will be there 6/16 to repair.

Residents may experience iron in the water for a few days. Fliers have been posted.

-Duplex pump control panel for filtration cost is \$5800 - this includes no valves/plumbing/labor.

8 Valves are need at approx. \$300-\$400/each with an approximate total for the project running around \$13,000 - \$15,000. Ahlers will get an estimate from Grasser's for the plumbing and labor for this project.

-An estimate was received from PC Painting for cleaning, priming, painting of the water tower.

Exterior: clean, prime, paint \$28,000 Interior: pressure wash, inspect, and paint \$4,000 Pressure Tank set-up: \$1,000 APPROXIMATE TOTAL: \$33,000

Sandberg will contact the bank to get information on taking out a loan for the water tower project and the control panel project.

Trustee Haar made a motion to proceed with the water tower project with a second coming from Wegrzyn. Motion carried.

-Once again, Ahlers informed the board that the level of arsenic in the water was above the recommended amount by 1 pt. - he is still waiting for prices for the median needed.

SEWER

- -Laterals have been cleaned at STP
- -Baskets will be cleaned 6/15
- -Ahlers obtained 2 estimates for the back up pump at the STP.
 - -PTO pump \$6269 plus \$550 for hoses
 - -Honda 4" \$3200 includes 4" hose kit

After discussion, Trone made a motion to purchase the 4" Honda pump, Wegrzyn seconded, motion carried.

- -Joe Glynn has suggested to Ahlers that alarms at the STP would be beneficial if pumps go down. Cost for the PLC upgrade would be \$10,800 plus ethernet cables. This was tabled at this time.
- -The hole in the alley south of Mike Porath's house has been repaired. ElectriCom bored through the sewer line last summer while installing fiber optic lines. B. Keller did the work and will send the Telephone company a bill who will in turn bill ElectriCom.

ENGINEERING

-Don Bixby from Chamlins will coordinate with Sandberg to ride around the Village to look at the streets for 2017 Street Maintenance Program. Sandberg will email board members when this is set up.

POLICE

- -VP Sandberg will be meeting with Granville's Chief Moore and one of his part time officers concerning working for the Village. Sandberg will report back after the meeting. Sandberg has been informed that he also does ordinance enforcement for another town.
- -There has been 2 more dog incidents since last meeting involving the dog on Theordore St.

NEW BUSINESS

- -Prevailing Wage Ordinance #240 was passed by roll call vote.
- -Reviewed the newly updated Appropriation ordinance new numbers will be sent to Attorney Churney for her to put together 2017/2017 ordinance.
- -Harrison reminded all board members that their Open Meeting Act online training must be completely ASAP.

- -A sample ordinance was distributed to the board for review stating that all new water/sewer accounts for renters will remain in the homeowners name and the homeowner will be responsible for paying all monthly w/s bills. After discussion, Harrison will have Churney draft an ordinance for passage in July.
- -The board was informed of a vandalism incident to a fence on Theodore St.
- -Haar has been approached by a homeowner stating that there is a pin tree in the alley between 8th and 9th Street that need to be taken down. Sandberg will contact the homeowner.
- -There a 2 dead trees in Centennial park Johnson Tree Service has been contacted to give us an estimate for removal. AAA Tree Service will be contacted if no word from Johnson.
- -A letter will be sent to a resident on 10th Street concerning a vehicle with expired sticker.
