RESOLUTION AUTHORIZING THE ADOPTION OF LOCAL LAW NUMBER 1 OF 2017 PROVIDING FOR THE INCREASE OF THE TERM OF OFFICE OF THE TOWN CLERK, TOWN TAX COLLECTOR, AND TOWN HIGHWAY SUPERINTENDENT, FROM TWO YEARS TO FOUR YEARS EFFECTIVE JANUARY 1, 2018 SUBJECT TO MANDATORY REFERENDUM

**WHEREAS**, pursuant to Section 10 of the Municipal Home Rule Law and Section 24-a of the Town Law of the State of New York, the Town Board of the Town of Hampton (the "Town") has the authority to adopt local laws increasing the terms of office of the Town Clerk, Town Tax Collector and Town Highway Superintendent from two years to four years, which local law must be subject to mandatory referendum; and

**WHEREAS**, the Town scheduled a public hearing to be held before the Town Board on August 17th, 2017 at 7:15pm at the Offices of the Town of Hampton, 2629 State Route 22A, Hampton, NY 12837, to hear all interested parties on a proposed Local Law to increase the term of office of the Town Clerk, Town Tax Collector, and Town Highway Superintendent, from two years to four years; and

**WHEREAS**, notice of said public hearing was duly posted and then published in The Granville Sentinel and Whitehall Times, the official newspapers of the Town on August 10th, 2017, pursuant to and in conformance with the Municipal Home Rule Law; and

**WHEREAS**, said public hearing was duly held before the Town Board on August 17th 2017 at 7:15p.m. at the Offices of the Town of Hampton, 2629 State Route 22A, Hampton, NY 12837, and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to the proposed local law; and

### NOW, THEREFORE BE IT:

**RESOLVED,** that the Town Board, upon due deliberation of the proposed Local Law to increase the term of office of the Town Clerk, Town Tax Collector, and Town Highway Superintendent, from two years to four years and subject to mandatory referendum, finds the same to be in the best interests of the Town of Hampton; and be it further

**RESOLVED**, that the Local Law to increase the term of office of the Town Clerk, Town Tax Collector, and Town Highway Superintendent, from two years to four years, a copy of which is attached hereto and made a part hereof is hereby adopted subject to mandatory referendum; and be it further

**RESOLVED**, that pursuant to and in accordance with Municipal Home Rule Law Section 23, Local Law No. 1 of 2017 shall be subject to mandatory referendum at the next general election on November 7th, 2017, whereby Local Law No. 1 of 2017 shall become operative only if approved by the affirmative vote of a majority of the qualified electors of the Town voting upon this proposition; and be it further

**RESOLVED**, that the Town Clerk is hereby directed to enter Local Law No. 1 of 2017 into the minutes of this meeting and file the same, along with an appropriate abstract, with the Washington County Board of Elections. Upon approval by the electors of the Town, the Town Clerk is directed to file Local Law No. 1 of 2017 with the Office of the Secretary of State of the State of New York; and be it further

**RESOLVED**, that this resolution shall take effect immediately.

Town Assessor Mary Ellen Hill-Pierce....Equalization rate was down, NYS has agreed with Mary Ellen's info and raised the rate back up to 100%.

Warren Cemetery.....at the grave marking held at the Warren Cemetery earlier this summer, Supervisor O'Brien met David Griffin of the Vermont Cemetery Association. Discussed conditions of the stones and repairing them. Need between 20-30 people for help. Supervisor may check with Alternative Sentencing for some help and to pick a Saturday in September to do the work.

Cemetery mowing....Supervisor O'Brien suggested alternatives for mowing town cemeteries...part-time worker or hiring out? Will discuss at future meeting.

Health Insurance....renewal rates are up 4.6% with current plan (MVP), other plans are higher. Will discuss further with highway employees.

Budget Forms for 2018 were handed out. Will start working on budget at September meeting.

### PUBLIC COMMENTS/COUNCIL COMMENTS

Regarding article in Whitehall Times about towns combining together....Governor is pushing for towns with villages to consolidate, not neighboring towns.

Tax Cap rate for 2018 is 1.84%.
