Mrs. Rhodes will have to work with Portage Township to be in compliance with the municipality's rules and regulation regarding potable water and land development.

Secretarial Report:

Solicitors Report

- PennVest financing at 1.734% is an excellent rate for borrowing funds. Application for PennVest funding when the permits are obtained.
- ➤ Kotzan CPA and Associates and the refinancing savings claimed as restrictive assets on the 2022 audit. 90 percent of the refinancing savings must be accounted for in allowable expenses before year end 2024, the accountant will report to expenditures to the IRS.
- People's Security- monthly payments interest verses principal, and the fixed payments in accordance with the refinancing agreement. Mr. Barbin is collaborating with representatives from Peoples Security to rectify the difference in interest and principal payments which differ from the Refinancing Loan Agreement Note.

- Engineering cost for the pole building, fine screen, pump station and a purchase of a Kubota tractor for the wastewater treatment plant.
- Solicitor Barbin reviewed the Engineering Agreement.

Motion made by Dennis Beck 2nd Jeff Hite to authorize the CMSA Chairman to sign the Engineers Agreement. Roll call, All in favor, Motion passed.

Engineers Report:

As Discussed:

1. Rotary Press And Pump Station Screen

Project would require a Part II permit which will take 6-10 months.

Leadtime for press is an additional 8-10 months.

New Engineering Agreement-Total Engineering is \$183,000.00

- Design and construction management - \$85,000.00- Building Permit-\$2,500.00- WQM Part II-\$20,000.00- Mapping- \$6000.00- Funding Admin-\$40,000.00-Construction Inspection-\$30,000.00.

2. PENNVEST Funding

Planning and consultation meeting was held.

Project cost estimated at \$1,100,000.00 includes sludge press and pump station screen.

PENNVEST anticipates Project will be 100% Loan (1.0% for year 0-5.-1.743% for years 6-20)

Monthly payments of \$5,431.82 or \$5.10 per customer.

Operating \$51,000 per year in black- profit

\$1.11 per customer monthly increase if \$51,000.00 is applied to the loan.

3. Storage Building

Current size is 32'X 52'X16' with four garage doors sized 10 X 12.'

Insulation, electricity, water, and steps are not included.

Bid concrete, fence, and barn trusses as additive alternatives.

Project will be design build- concrete floor, barn trusses and fencing will be bid separately,

The use of Knop and Klatt for the catch basin at the wastewater treatment plant.

WWTP Report:

As Discussed:

- Submitted monthly DMR Report.
- Downloaded flow meters.
- Pressed sludge and hauled out a load of sludge.

- The truck was serviced and inspected and was told the tires need to be replaced prior to the next inspection.
- > Serviced samplers and replaced the tubing that draws the samples.
- > Scaffolding purchased and made repairs to effluent water line in tunnel #2.
- > UPS (battery back-up unit) was replaced to the main control panel.
- ➤ Bridgeway Cummings was at the pliant to service the outside generator, recommended batteries to be replaced, the old one are around six years old and under load does not have enough amps. Also, the radiator hose needed to be replaced.
- Ram dropped off the lift station pump that was pulled to be rebuilt now CMSA has a spare pump on site.
- ➤ Had issues with the press discharge pump. The paddles inside the hopper sheared off two bolts, was able to disassemble, drill and re-tap the bolts.
- ➤ Plant manager was called down to the plant on the night of April 3rd, for high flows alarm due to the large amount of rain the area was receiving.
- ➤ Kubota is dead, the motor finished. Plant manager is having issues with coolant getting into the oil. Trying to move the lift station pump into the building when the motor locked up, then drained the oil and the oil had metal shaving and chunks in it.
