#### **III. Presentation:**


A. District C Update: Abby Kamin regarding the bar noise, crime and uptick in crime. Her office is in touch with HPD on a regular basis regarding all the issues. Meeting with city prosecutors concerning the gaps and cases being back logged. City has approved more officers. Mayor has met in a closed door meeting regarding the problems with bars. A pilot program Shot Spotter System that detects gun shots. Also looking a camera systems. HPD is working on a citizen information system. Road safety - increase in HPD, all law enforcement agencies, as well as unmarked vehicles and seeing some effectiveness. For more information go to www.houstontx.gov/council/committees/pshs/20210715/safe-roadway-initative/pdf A stronger noise ordinance is in the process, Mayor Turner is very supportive. Water Bill increases – this was not an easy vote. The city is legally required to upgrade our systems, and these upgrades were not done within a timely manner and EPA was going to fine the City of Houston 7 Billion dollars, the Mayor negotiated to 2 Billion with the upgrades being done within a specific time frame, thus the reason for the increase. These funds from the increase have to be used by law for these upgrades. Leigh Kilgore asked if when the \$2 Billion is reached will the increase go away, no it will not, infrastructure has to be maintained. Shepherd Drive project - will have protected bike lanes, better drainage and better sidewalks when completed, there will be a meeting, flyers will be going out. Residents and businesses that will be impacted will be contacted. This large project will be starting in August. Washington Roundabout – pushing for creative ways to improve and fund this project. With the bricks and severity of the condition, it's going to need complete reconstruction. Railroads – big push at the city to bring the attention of the trains, during the winter storm the trains got stuck blocking thorough fairs, and keeping emergency vehicles getting through. Some areas the trains are sitting all day. A flier will go out on how to report trains. Train track at Oliver St. there is not a quiet zone for that section. Olivewood received a grant and only 40 recipients in the entire nation, this will help restore the cemetery. Huge congratulations.

**B. Central Command Update:** Sgt. Chad Wall, update on patrols, teams have been out regularly with an increase in funding they received. Things have quieted somewhat. Stacie mentioned Center & Roy with parking issues. HPD inspected clubs and issued 44 citations. TBAC is aware and looking into all the issues and violations. Kay Walton asked the time frame of the inspections, these were done in June. They do them as they are needed ie problems, call ins. ARA and the Health Dept. also go on the inspection. Stacie informed HPD National Night Out meeting and she will forward that info to HPD.

#### **IV. New Business:**

A. Detering One Way Project: Public works is involved with these issues and Julia Retta has requested for Detering to be ne way from Washington north to Schuler, requested back in 2019. Has been reviewed and is still being reviewed, looking for public input and having a public meeting. A notice will go out as to when. SN22 at this point to support because of the effects it will have to the neighborhood.

- **D.** Lowering Residential Speed Limit update: Dexter Handy, gave an update, time ran out for the bill to be presented to the senate, however it is still on the radar. There will be a campaign to get drivers to slow down.

- **C. Quality of Life Updates:** Stacie Fairchild, Bubbas is changing to "Knock Out" which is kind of like Hooters, owner lives in the neighborhood, so hopefully will be a good neighbor.
  - **D. City Council and Department Updates:** Linda Trevino, August 3<sup>rd</sup> all super neighborhood neighborhoods are invited to participate in a work shop 6:00 pm, zoom discussing stations on the inner Katy Alignment, comments have been taken under advisement. August 16<sup>th</sup> there will be a open public meeting with more details also zoom. Implementing a dedicated bus lane trial on Travis and Milam in August. Diamond lanes will be reinforced.
- **E.** Jack Valenski, 311 application issues with the new system, won't accept pictures larger than 5 mg right now. Waiting for app approval through apple and or google, so that you can do reporting on your phone. There is also going to be a replacement app for solid waste.
  - F. Super Neighborhood Alliance: SN22 Alliance met and Stacie Fairchild will be heading up a safety committee. Typically SNA do not meet in August, question was raised if there were any objections to having an August meeting. No objections. SNA was in touch with Houston Public Works and asked that the increase be tabled.
