We are **Growing Together!** 

The Windgate Foundation and First National Bank of Izard County are making possible a major expansion of the Calico Rock Museum & Visitor Center. The purchase of the historic Calico Rock Hardware Company building will triple the size of our Art Center, double the Ben Sanders Discovery Center, provide a permanent ground-level Archives, and a three-bedroom vacation rental on Main Street providing perpetual income to the Foundation.

Early last year, we finished the *Lofts off Main*, expanded the **Artisan Gift Shop** and the **Tomlinson Art Gallery**.

Together, we are enhancing guests' experiences with guided tours and interpretations by our Program and Museum Manager **Denny Elrod**. Denny is adding details to existing exhibits, researching new exhibit ideas, and providing innovative ideas and a fresh perspective. His addition to our team solidifies our bedrock principle that preserving our history and telling our story is the centerpiece of the work we have always done.

As a team, we are expanding the **Sue McClusky Birth of the Ozarks Gallery**, including a scale replica of the **Second Izard County Courthouse** that was located at Athens and an expanded exhibit memorializing the **Trail of Tears**.

And, finally, we continue to diversify our revenue stream with **commercial rental properties** in revitalized historic buildings. We are opening doors of opportunity for small businesses and growing our community together.

# yesterday.

The famous cartographer and explorer Schoolcraft traveled up the White River to the place French fur traders had name Calico Roche, because of the calicocoloring on the bluffs rising out from the river. When the railroad began construction along the river in 1903, We met those rocks and nearly met their match.

The railroad blasted away huge chunks of those bluffs to make way for the railroad bed and sent those huge boulders into the river. Many thought our namesake calico-coloring was gone forever. Over 200 years later, those huge boulders still jut up from the riverbank and the calico-coloring has returned. And, Calico Rock is still **the only place in the world** with that name.

The Calico Rock Community Foundation was formed in 2008. At the time, our sole purpose was to create and operate the Calico Rock Museum & Visitor Center. Since then, we have restored nine historic buildings; sparked an economic revitalization driven by the creative economy; built a museum of national acclaim focusing on science, history, and art; highlighted our artistic community; and served our local businesses.

The foundation has invested \$3 million and provided a \$17 million economic impact on Calico Rock, Izard County, and Arkansas.

We are *preserving our past*, celebrating today, and *building a better tomorrow*.


The Foundation has welcomed over 275,000 visitors to Calico Rock since 2008.







## A Transformation Story



It was 2005. The historic buildings that had once formed a railroad boomtown were vacant with just two businesses operating in them. Windows were broken and staying in place simply by habit. Paint had faded. Weeds were poking through concrete sidewalks. Calico Rock had become little more than a ghost town. Something had to change.

Enter a group of concerned residents, some of them local and some of them from "off." Together We formed a group We called CORE (Calico Rock Organization for Revitalization Efforts) to try to make a change. We started pulling weeds, painting storefronts, adding solar powered streetlights, and collecting the town's history for interpretive signs. The 2020 Group had worked on a similar mission to beautify Main Street, but CORE worked on economic revitalization. Despite being advised not to focus on the town's history, we had the foresight to make Calico Rock a historic tourist destination. We were ahead of their time.

We also rejected the advice of experts and decided to open a small museum for the town. CORE wanted to revitalize, not operate, so the group spun off the museum project to a smaller committee. Ultimately, that committee formed the Calico Rock Community Foundation.

The Foundation applied to become a 501 (c) (3) tax exempt organization and started raising funds, accepting family heirlooms and historic artifacts, and working to open the small museum. We opened the museum in the backroom of the city's Visitor Center on Main Street. It was barely open a few months before a unique opportunity presented itself. The adjoining building was for sale at a discounted price to the Foundation, but We had to act quickly. The Foundation did not even have a bank account at the time, but a gift from founding trustee Rev. Ed Matthews allowed the Foundation to open an account with \$500. The local bank took a leap of faith and loaned the Foundation \$65,000 to buy the building.

Those two actions were the first steps toward a fifteen-year effort to preserve the historic buildings on Main Street and revitalize the local economy. With a new building that was falling in around them, a bank loan, no revenue, and a tenant that decided to move out, the Foundation looked like its first action would be its last. Challenges give way to opportunities.

The Foundation's volunteer executive director, Gloria Sanders, struck up an idea. Invite local artists to rent booth space in the new building with a portion of their proceeds supporting the effort. To the surprise of most, artists came and soon the building's main floor and basement were filled with artisans. The mezzanine became the museum.

A partnership with the city provided needed funds to hire Sanders as a full-time executive director, install a bigger Visitor Center, expand the museum into the arts, and start the economic

development that was being driven by the arts. Sanders and the Foundation's board chairman, Steven Mitchell, soon realized there was something lacking on Main Street. Food. To get more people to stop along Scenic Highway 5, Calico Rock needed a restaurant on Main Street, and, in Sanders' and Mitchell's view, it needed to rival something that could be found in the city.

The board agreed with their vision and another opportunity presented itself. The Foundation, which had already paid off the museum's building loan and completed renovations, borrowed money again to buy another building on Main Street and opened the Printing Press Café. With black and white interior designed by Mark Green, the Printing Press was in the town's original newspaper office and featured upscale dining with hometown service. The proceeds from the Printing Press fueled more historic preservation and community efforts.

Soon, the museum had outgrown its space. With no option for growth, the Foundation looked across the street. The Foundation had already purchased one of those buildings that had housed Don Quixote's Restaurant, one of the two businesses that were operating when the group's efforts had begun. The museum had installed an Art & Science Center, but it was difficult to operate in two locations with two staffs.

The Foundation bought the two adjoining buildings and connected them. The work could not have been done without the City of Calico Rock and Mayor Greg Hamby offering his own expertise and labor, city employees, and local inmates to help do the work. Soon, the buildings were preserved, restored, and the museum now had 14,000 square feet of space.



The work of the Foundation to transform and grow Calico Rock is continuing. The Foundation sold the original building We bought on faith and used that money to buy another historic building and save it. Today, the Foundation owns the three buildings that house the museum and five buildings We rent for commercial purposes. We are completing work upstairs of one of those buildings to offer offices and studios for rent. The Foundation rents all these spaces at affordable prices, with utilities included, to encourage economic revitalization and opportunities. It is part of their mission and goal.

Over the past fifteen years, the Calico Rock Community Foundation has renovated nine historic buildings on Main Street. We have opened or supported ten small businesses. The Foundation has raised and invested \$2,800,000 into the local community. Today, the Foundation continues to operate the Calico Rock Museum & Visitor Center, Artisan Gift Shop, partners with the City of Calico Rock, partners with the Calico Rock Artisan Cooperative, operates Main Street Calico Rock (a designated Main Street program), has an endowment fund, employs three full-time staff members, and supports our local community.

All of this from so little. It is a testament to what a small group of committed dreamers can do to change their local community.

#### GLORIA SANDERS EXECUTIVE DIRECTOR 870-916-2230




## **Artisan Cooperative**

## Christmas in Calico











#### Growing Together.



The Calico Rock Museum & Visitor Center is busting at the seams and needs room to grow. To remedy the problem, the Calico Rock Community Foundation has purchased the historic Calico Rock Hardware Company building, located next door to the museum. This expansion will nearly double the size of the museum and provide space for new exhibits, archives, gatherings, and classrooms.

The Tomlinson Art Gallery will more than double in size, a major component of the project. This will allow the museum to display all the works in the collection and add sculpture and installations, which was not possible before this expansion. It will also include a new discovery center, make the archives, and research center more accessible.

When completed, guests will be able to enter the museum at an expanded Birth of the Ozarks exhibit, continue through the heritage museum, the science center, the new discovery center, and finish their tour in the art center. The complete round trip will be easy for guests to navigate and explore.

The **Windgate Foundation** has awarded the museum with a significant grant for the purchase and renovations. This grant requires local donors to invest in the project, as well. The Windgate Foundation is challenging the community to get behind the project and support the museum.

## In Memory of Jimmy Walters



In late 2024, the Calico Rock Community Foundation lost a valued member of our family. Jimmy Walters lost a short battle with cancer.

Jimmy graduated Calico Rock High School in 1987 and spent several years working construction in Oklahoma before relocating to Calico Rock. Jimmy was a carpenter by trade, managed B & B Supply in Pineville, and used his hands and the talent God gave him for the betterment of others.

God *chose* a carpenter. He chose a carpenter to care for His Son, to be an earthly father for Him. God chose another carpenter. He chose that carpenter to care for our community, to preserve a few pieces of our history, and to share kindness with old friends when He sent Jimmy Walters into our lives. He chose the right time to bring us together and for that we would forever be grateful.

A carpenter's hands are usually rough from working in the weather, using their talent and skill to shape and mold, but the results of their labor become a work of art. Jimmy Walters was a craftsman, a skilled carpenter with experience and a heart of gold. He transformed a dingy basement into Tommy's Clubhouse, a long-ago abandoned attic into the Lofts Off Main, and connected each of the buildings of the Calico Rock Museum with a beautiful outdoor deck in a once-forgotten Peppersauce Alley.

While preserving those old buildings and bringing character and life to a century of history, Jimmy transformed us. He taught us kindness, humility, overcoming any challenge that may face you, and being a friend to those in need. We witnessed Jimmy's constant pursuit of finding the good in others. He was a gift from God. He shaped all of us while he was shaping the lumber and driving the nails.

It's impossible to measure the impact a person has in their life, the difference a carpenter can make on the world. A man of humble means living a life, using the talent God gave him to do the best he can to make each day a little better for those around him. This was the story of Jimmy Walters, a life that will not be recognized on the national news but whose life made a difference in our world...well done, thy good and faithful servant, well done.

### In Memory of Peggy Hudson



She lived on Main Street in Wiseman Hotel with her parents, Tip and Retha, in the blue building on upper Main Street where Cooper's Antiques is located today. She never stopped loving Downtown Calico Rock. We learned this morning that Peggy Wiseman Hudson has gone to be with the Lord and all of us in Calico Rock are mourning her loss.

Inside Wiseman Hotel, she ran up and down the grand staircase, listened to all the tales from travelers that filled the hotel with the latest arriving train, and spent time with her friends in the businesses along Main Street.

She loved it when the train arrived because it carried all kinds of surprises, and sometimes it brought a big bunch of green bananas. She learned what happens when you eat too many of them the hard way, but it never curbed her love for them.

Years later, she and her husband, Dean, who also spent a lot of time growing up on Main Street, started the efforts to save all those old buildings that had fallen into the pages of history. She lived to see those buildings full and thriving again, people laughing and shopping and enjoying the street the way she remembered it as a kid. She and Dean attended meetings and work sessions together for a time, until her health began to falter and she began cheering from home.

In 1952, she married Elmer Dean Hudson, a school teacher and administrator. While he was busy at school, they joined her parents in founding White River Healthcare & Rehab, a skilled care nursing facility. They borrowed \$98,000 and opened the facility on top of the hill overlooking the mountains and White River in 1967.

Peggy became the administrator but earned her nursing degree because she wanted to know everything the nurses knew and she wanted to help them care for the patients. When Dean retired from the school business in 1975, she told him he was the new administrator and she headed to the floor caring for those patients she loved dearly. They created far more than a nursing facility or family business. For the residents of White River Healthcare, many of them living there for decades, they created a home. They were family.

While Dean was a founding trustee for the Calico Rock Community Foundation and one of the five founders of the Calico Rock Museum & Visitor Center, it was so many talks in her living room over fresh-baked cookies that produced so much of the work you see today. She was a consultant, historian, editor, and the greatest cheerleader the town has ever known. There are many who love Calico Rock, Peggy Wiseman Hudson ADORED it and worked quietly behind the scenes to bring it back to life.
