TERMS AND CONDITIONS

ITEMS: ALL ITEMS BEING DISPLAYED OR SOLD MUST BE 90% KNIFE RELATED, UNLESS APPROVED BY "GREAT LAKES KNIFE SHOW." NO GUNS OF ANY KIND ARE ALLOWED. ALL ITEMS MUST ABIDE BY LOCAL, STATE AND FEDERAL LAWS AND REGULATIONS.

FEES: All table/booth fees are required at signing, to confirm and maintain your date at the "GREAT LAKES KNIFE SHOW 2017". Registration will not be guaranteed or binding without your total fee being received and the contract being signed.

CANCELLATIONS: The total fee is non-transferable. In the event of cancellation, a refund will be given only if canceled at least 60 days prior to the event and only if your registration can be filled by another approved party. All cancellations must be in writing and will be effective when received by our office.

BAR ARRANGEMENTS: Eclipse Event Center, LLC is the licensed purveyor for all alcohol services at the "Eclipse Event Center". ALL bar and alcohol arrangements must be arranged and served by Eclipse Event Center. Likewise, NO CARRY INS of any kind of alcoholic or traditional "bar" items, including soft drinks, is allowed. Any alcohol consumed or brought into the "Eclipse Event Center" is unlawful and will be just cause to immediately halt or end your event, even if in progress. Eclipse Event Center reserves the sole discretion to refuse service to any guest for any reason including intoxication.

TAXES: Where applicable, you are responsible for reporting and paying all taxes related to this event.

DECORATING. The "Eclipse Event Center" does not permit the affixing of anything to the walls, floors or ceilings of rooms with nails, staples, tape or any other substance. The cost of damages due to unauthorized or careless decorating will be assumed by you. Open flame candles are not allowed on the premises (votive candles in glass containers are acceptable). Pyrotechnics of any type are not allowed. All decorations will be removed at the end of event.

PERSONAL PROPERTY RESPONSIBILITY: IT IS RECOMMENDED THAT EACH PARTY MAINTAIN COMPREHENSIVE INSURANCE FOR THE DURATION OF THIS EVENT. The "Eclipse Event Center," "Great Lakes Knife Show," "Woodlab Outdoors, LLC" and any of their members expressly disclaim liability for and do not assume responsibility for any and all injury, the loss of or damage to any personal property, equipment, merchandise or articles left in the facility prior to, during or following any function under any circumstances. Proper insurance and/or security of items is the responsibility of the party signing this Registration Contract.

DAMAGES: As the party signing this Registration Contract for the "Great Lakes Knife Show," you are responsible for any and all types of damages or vandalism to the facilities caused by your guests, their guests, any users, invitees or any of the general public that attends your tables and or booths. Such damages will be billed to you, not at the original purchase pricing, but the replacement value or the cost to repair.
