# Absolutely Abstract Art Exhibition

## The Encyclopedia Britannica states:

“Abstract art, also called nonobjective art or nonrepresentational art, painting, sculpture, or graphic art in which the portrayal of things from the visible world plays no part. All art consists largely of elements that can be called abstract—elements of form, color, line, tone, and texture. This exhibit will focus on the subject of abstract, both 2-D and 3-D. Painting, drawing, sculpture, mixed media, art glass, fibre arts, hand pulled prints, photographs, and original digital prints are welcome.

**Jury Fee:** The non-refundable jury fee is \$35 for TNPS members, \$50 for non-members. Each fee allows you to submit up to three (3) entries per show.

**Acceptance and Exhibiting.** Artists accepted will receive information pertinent to drop off, pick up dates, opening dates, etc. Only **accepted** work is allowed for exhibition. No substitutions. All work is to remain on exhibit for the duration of the show. TNPS reserves the right to refuse any work damaged or deemed too fragile for exhibition.

**Specifications:** The maximum size not to exceed 48” x 48” and 40 lbs.

**Framing:** Frame must be wired for hanging. No other types of hangers are allowed. All other work must be ready to install. TNPS reserves the right to install accepted works in a manner deemed necessary for exhibit or security reasons.

**Submissions:** Images of work may be submitted by email or regular mail. All images must be labeled clearly in whatever format chosen. The entry form may be scanned or the information emailed to [nps@grics.net](mailto:nps@grics.net). Payment may be made online via PayPal to [nps@grics.net](mailto:nps@grics.net). Send application, payment and materials to The Next Picture Show, 113 West First Street, Dixon, IL 61021.

**Sales:** Exhibited works will be considered for sale at the price indicated during the submission process. Works not for sale must be designated “NFS”. We recommend a 25% donation to TNPS of the retail price for any artwork sold.

**Publicity:** TNPS reserves the right to photograph all exhibited work for publicity purposes.

**Jurying:** Only entries postmarked by indicated deadlines will be considered. All CDs and pictures will be retained until exhibition end.

**Awards:** Best of Show, 1st, 2nd, 3rd, and Honorable Mention (may be more than one).

**Delivery & Return:** Accepted work may be shipped or hand delivered to TNPS. Hours: Tuesday—Saturday, 10:00am—4:00pm. Artists are responsible for insuring their work in transit to and from TNPS. TNPS provides minimal insurance for work while on TNPS premises.
