Committee Reports

<u>Councilman Austin</u> - Councilman Austin reminded everyone that the Beef and Beer Fundraiser for the Police Department K-9 Unit is on March 21 at 7:00 p.m. at Masso's Crystal Manor in Glassboro.

On April 1, WHYY will do a live broadcast from Theater Avenue. Theater Avenue will be closed from 2:00 p.m. until midnight for that event.

Detective Sgt. Moore, Ptlm. Carson, and Cpl. Streater have been attending training classes this month.

Councilman Austin announced that work will begin on West Holly Avenue and will continue for an estimated six months. The project will cause road closings, and the Gloucester County Roads Department is working with Traffic Safety Officer Owens to coordinate the closings.

Council President Razze – Council President Razze reported that the Recreation Commission met this past Thursday evening. The winter programs are coming to an end; T-Ball will be starting in the next week. The tennis program will start at the end of March. This year, participants in the Fourth of July Freedom 4-mile Road Race will be able to register at Borough Hall and online for the first time. The Recreation Director and Alcyon Park Supervisor have finalized their interviews for the full time park assistant. The Director is also working on basketball programs that will start in late spring and go into the summer months.

Council President Razze stated that on March 7, he had the pleasure of reading to fourth grade students at W.C.K. Walls Elementary School. It was nice to be part of their "Read Across America" activities.

<u>Councilman Pierpont</u> – Councilman Pierpont read the following report:

As the snow melts and streets get clear, storm drains and potholes become the priority. Our crews are out working to clear standing debris from our storm drains and repairing potholes. If anyone sees potholes please call 589-1040 to report the location and a crew will be dispatched as soon as possible.

Following are the recycling numbers for January 2014 24 loads of single stream recycling for a total of 117.34 tons, for which the Borough was paid \$1,395.16

Councilwoman Higbee – Councilwoman Higbee read the following report:

On March 4, the Pitman Memorabilia Committee met at the Museum on the Circle. Water is collecting in the window well on Seventh Avenue due to pooling on Seventh Avenue near the Circle. Some grading is needed to get the water to the drain across the sidewalk. The museum will be open on March 22 from 1:00 until 4:00 in the afternoon. We have received two beautiful photographs of cottages in Pitman. Luckily these both have dates, names, and addresses. They are the Thomas Covington cottage on Southwest Avenue in 1899, and the Duffield cottage at 49 Fourth Avenue in 1901.

This Thursday evening the Historic Commission will meet at Borough Hall to hear applications for the exterior of properties within the Historic District. Currently there are two applications to be considered this month.

Beth Walls, our tax collector, has submitted her collector's annual statement of receipts and

disbursements for the year 2013. The total deposited by the collector into the current account in 2013 was \$21,744,275.96. Also, tax payments collected in the month of February were \$3,100,524.06.

We have received our certification of state aid for the calendar year 2014 and fiscal year 2015 budgets. Amounts in line items have shifted but our total aid remained flat at \$638,447.00. I looked back to our 2008 state aid award amount and it was approximately \$830,000.00, reflecting a \$200,000.00 annual decrease since 2008.

At our Work Session budget meeting tonight, we discussed the Planning/Zoning budget, the Environmental Commission budget, and the Public Property budget. Our next budget meeting will be held on March 19 at 7 o'clock in the evening.

On March 7, I had the pleasure of reading to Fourth Graders at W.C.K. Walls Elementary School. It was nice to be part of their "Read Across America" activities.

In January, the Construction Office issued twenty-three permits, processed three certificates, collected \$6,697.00 in permit fees, and \$335.00 in miscellaneous fees.

The Borough's Code Enforcement Officer continues to work on the registration of abandoned or closed properties located within the borough.
