Thank you for your interest in the Augusta Diving Club. I am Jim Tingen and the springboard diving club is for divers, ages 7 through 17, who would like to learn how to become a better diver and would like to compete with other divers his or her age.

I was the North Carolina High School State Diving Champion in 1972. I went on to dive for the University of South Carolina from 1972 to 1976 and was the Swimming and Diving Team Co-Captain my senior year. I qualified and competed in the NCAA Diving Championships my junior and senior years. I finished top 40 in the nation on both the low and high boards.

In 2009 I was asked to coach the Lakeside High School Divers. Our five divers developed their skills and consistently scored high points for the Lakeside team. Because of the increased interest in springboard diving, I started the Augusta Diving Club in the spring of 2010 with 3 divers and since that time I have trained over 25 high school divers, 15 age group divers and provided summer diving clinics to over 75 young divers at area community pools.

My goal is for each diver to be safe and enjoy the sport of diving. For those who have the desire, dedication, and discipline, I would like them to be able to compete successfully in high school and aim to earn a college diving scholarship. In addition to becoming an improved and skilled diver, my goal is that each diver will become more confident in himself or herself, on and off the diving board. In addition to coaching, I work for CallingPost Communications where we help organizations "Turn Groups into Teams and Intentions into Realities".

## Augusta Diving Club Permission Form

In consideration of being able to participate in the Augusta Diving Club Programs, events and activities, the undersigned:

Release, waive, hold harmless, discharge and covenant not to sue the Augusta Diving Club, its affiliate clubs, their respective administrators, directors, agents, coaches, owners and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owner and lessors of premises used to conduct the event, all of which are hereinafter referred to as released from any and all liability to each of the undersigned, his or her heirs and the next of kin of any and all claims, demands, losses or damages on account of injury, including death, damage to property caused or alleged to be caused in whole or part by the negligence of the releasee or otherwise.
