Home Style Chili Contestant Rules & Regulations

1. Home Style Chili is defined as any kind of meat or combinations of meats, cooked with chili peppers, various spices, beans and any other ingredients. HOME STYLE CHILI MUST INCLUDE EITHER BEANS OR PASTA.
2. Home Style Chili will be judged by local individuals that have purchased a tasting kit. Tasting kits will include tickets for samples and one voting ballot. Contestants must receive a ticket in order to give out a sample to the public. The public will then vote for the one chili they think is best. Ballots will be tallied and the winner will be determined by the contestant with the most votes. Your chili will also be judged in a separate category with Professional Chili Judges.
3. Contestants will be assigned a 10x10 space. Contestants must provide "ALL" equipment and ingredients for their space and team. We have a small supply of extra long gas hoses for contestants use on 5 gallon propane tanks that comply with fire regulations. All Contestants MUST attend a Pre-Event meeting on Wednesday, May 3, 2017, @ 6:00 pm to be conducted by chief Judge. The location of this meeting is the Pavilion @ Elk Grove Regional Park
4. No ingredient may be pre-cooked in any way prior to the commencement of the official cook off. Meat may be treated, pre-cut, or ground. MEAT MAY NOT BE PRE-COOKED. All other ingredients must be chopped or prepared during the cooking/preparation period.
5. Home Style Chili must be ready to serve at 12 noon.
6. Each contestant must cook a minimum of SIX (6) gallons of Home Style Chili.
7. The Chief Judge shall conduct a contestant's meeting, at which time, any final instructions will be given and questions answered. The meeting will be held at 8:30 am on May 6th. All contestants MUST attend this meeting or be disqualified. Meeting location: Judges Tent @Elk Grove Regional Park.
8. Contestant will be responsible for cleaning up their area at the end of the event; including but not limited to wiping down and folding tables and chairs and removing all garbage.
