4. The meeting of the 7th AGM of HALE was convened at 11.30 hrs on 20th November 2016. Sri G.Prasanna, Hon.Secretary, HALE announced that there was quorum to conduct business as more than 380 members were present.

5. Sri Naresh Chandra Agarwal, President HALE presided over the General Body Meeting. The meeting observed a minute silence to pay homage to members who expired since the last AGM.

6. The Annual Report of the AGM conducted on 22nd November 2016 for the year 2014-15 was presented by Hon.General Secretary Sri G.Prasanna. It was adopted by the General Body unanimously.

7. General Secretary also detailed the Activities during the year since the last AGM held on 22nd November 2015.

- Executive Committee met 3 times during the year.
- HALE held a meeting with CMD of HAL in September 2016 wherein issues related to the retired community of HAL and HALE was discussed. Improvements to HAL Group Health Insurance Scheme, HAL Pension Scheme, Formation of Technical groups, how HALE can productively involve in HAL activities were among the various issues discussed. CMD-HAL was very receptive.
- The draft paper on pension for Ex employees will be prepared and forwarded to HAL, Corporate Office.
- On a request from HALE, HAL has agreed to provide officers retiring from HAL service a copy of HALE member ship form to facilitate them to enroll with HALE.

- 8. General Secretary also detailed the Activities that are likely to be taken up in future.
 - Main task for HALE is to establish a data base skill of HALE members and participate in the Skill Development work at HAL / AASSC. HALE may have to supplement the Data base of Skills seeking information from other officers who are not members of HALE.
 - A top up Policy on GHI will continue as done in December 2015 / January 2016 which will be effective from 1St February 2017. Members present at 7th AGM to canvass this with all HAL retired community such that maximum members subscribe to this policy. Reps from United India Insurance Company Limited and Medi Assit were present at 7th AGM and provided the details of top-up scheme HALE members.

9. Mr. Naresh Chandra Agarwal, President HALE addressed the gathering and requested the members to give full support to ventures that are likely to be taken up by HALE. He also informed the members to continue to use the top-up on GHI to be made effective from 1st February 2017.

10. The meeting was then declared open to members for interactive session. The queries were generally on GHI Scheme, Pension for all HAL personnel, and other related issues. All the queries were satisfactorily answered.
