This agreement is made this _____ day of _____ in the year _____, by and between Shadow Cat Advocates, hereinafter referred to as "Rescuer," and _____, hereinafter referred to as "the Foster."

I, _____, agree to be a foster parent and care for a cat/kitten or cat(s)/kitten(s) belonging to Shadow Cat Advocates, Inc. under the following conditions:

1. I understand that the Officers of Shadow Cat Advocates, Inc. retain legal ownership of said cat(s)/kitten(s) while it is in my care, and the cat(s)/kitten(s) will be returned to Shadow Cat Advocates, Inc. at any time that they request. This includes any kittens born to this cat.

2. I agree to isolate any incoming cat(s)/kitten(s), including this cat(s)/kitten(s), from all other cats not arriving with this cat(s)/kitten(s) for a minimum period of 6 weeks or longer, depending on the results of veterinary checks. I understand the need for isolation to protect my own cats and other cats and I do have the ability to isolate this cat(s)/kitten(s) from all others. _____
3. I understand that Shadow Cat Advocates, Inc. holds final authority over all decisions concerning this cat(s)/kitten(s) including medical treatment, foster home placement, euthanasia, and adoption. I agree to respect any decision that Shadow Cat Advocates, Inc.

makes concerning this cat(s)/kitten(s) and to help execute these decisions when I am asked and able to do so. _____

4. I agree to provide appropriate, high quality food and water for this cat(s)/kitten(s) in a healthy and sanitary manner. I will ensure that this cat(s)/kitten(s) has access to these things at all appropriate times. _____
5. I agree to provide a litter box with cat litter. I will scoop daily, and regularly clean and disinfect this litter box, to maintain a healthy environment with minimal odor. I also agree to clean any litter box materials (litter, urine, etc) in a timely fashion should these materials appear outside the box. _____
6. I agree to treat this cat(s)/kitten(s) in a kind and respectful manner, encouraging good behavior and confidence in order to create a well-adjusted, adoptable cat(s)/kitten(s). _____
7. I agree to maintain a healthy level of cleanliness for this cat(s)/kitten(s) and her/his surroundings. _____
8. I agree to make myself reasonably available to prospective adoptive parents for this cat(s)/kitten(s). I agree to set up times for prospective adopters to meet this cat(s)/kitten(s) when they call expressing interest. I agree to discuss this cat(s)/kitten(s) with prospective adopters in a very honest and forthright manner. I agree that Shadow Cat Advocates, Inc. will have the final say in all placement arrangements and I may not place a cat(s)/kitten(s) without their approval. _____
9. I understand that while Shadow Cat Advocates, Inc. may make recommendations concerning how to deal with this cat(s)/kitten(s) on a daily basis, including quarantine, training, etc, these things are under my control and not their direct control. I therefore take full responsibility for any damage this cat(s)/kitten(s) does to my living area, pets, belongings, or myself with the understanding that these things occurred because I did not properly protect my living space, pets, belongings, or myself from this cat(s)/kitten(s). _____
10. I understand that negligence of any kind regarding this cat(s)/kitten(s), particularly negligence which results in injury to this cat(s)/kitten(s) will be dealt with on an individual basis. I will comply with any decision Shadow Cat Advocates, Inc. makes concerning negligence, whether it be removal of this cat(s)/kitten(s) from my care, or asking me to pay for all or some veterinary fees incurred, or refusing to allow me to foster any more Shadow Cat Advocates, Inc. cat(s)/kitten(s), or any combination thereof. _____
11. I agree to notify Shadow Cat Advocates, Inc. immediately of **any kind** of problem concerning this cat(s)/kitten(s) that arises. _____
12. I agree to administer proper medications, etc, as prescribed by this cat(s)/kitten(s) veterinarian. I agree to abide by any other recommendations made by this cat's veterinarian or by Shadow Cat Advocates, Inc. concerning medical issues. _____
13. I understand that I am not guaranteed reimbursement for any expenses that are not first discussed with Shadow Cat Advocates, Inc. _____

14. I agree to communicate regularly with Shadow Cat Advocates, Inc. concerning this cat(s)/kitten(s). I agree to notify Shadow Cat Advocates, Inc. if I am planning for a vacation or move at least three weeks in advance so that they can decide what to do with this cat(s)/kitten(s) at that time. _____
15. I certify that by taking this cat(s)/kitten(s), my family and I will not be in violation of any local legislation or numbers limits. _____
16. I certify that I have never been charged with animal cruelty, neglect, or abandonment. _____

I certify the above to be true and complete to the best of my knowledge.

This agreement shall be interpreted under the laws of the State of Virginia. The federal or state courts located in Virginia shall have jurisdiction to hear any dispute under this Agreement, and Fosters hereby submit to personal jurisdiction by said courts. The parties agree that money damages may be both difficult to ascertain and insufficient to compensate a party aggrieved by a breach of this agreement, and that an aggrieved party may therefore be entitled to injunctive or mandatory relief including return of cat(s)/kitten(s).
