## LICENSE-FREE SALTWATER FISHING DAYS

Florida Sheriff's Ranches Enterprises Board of Directors and serves as Vice President of the Florida Sheriffs Association. Sheriff Nienhuis is the Chief Law Enforcement and Correctional Officer of Hernando County. As a constitutional officer, the Sheriff has the exclusive authority to administer his agency. He is responsible for preserving the peace throughout the county, carrying out the laws of the state, the order of Florida courts, and the ordinances of the Board of County Commissioners.

License-free fishing days provide an excellent opportunity for those who don't yet have a fishing license to experience fishing, take youth fishing, or for avid anglers to introduce a friend to fishing without having to purchase a license. On these days, the fishing license requirement is waived for all recreational anglers, including both residents and non-residents.

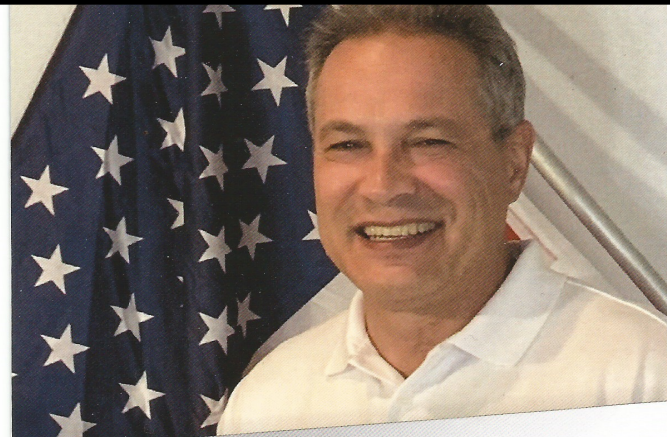

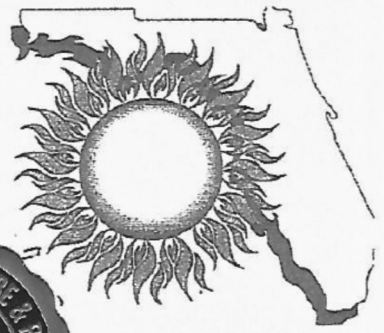

#### MAY FISHING REPORT

May is a great time for cobia fishing. There are many ways to target cobia from deep water wrecks and ledges to shallow rock piles and grass flats. My favorite way to target cobia is looking for sting rays in shallow water and sight fishing for them. Cobia will usually eat just about anything you put in front of them; I like to use live pilchards. Mid-day high sun and an incoming tide in 2 to 6 feet of water just outside of the islands is a great place for cobia; put the sun to your back and start looking.

Deep wrecks are a magnet for cobia; anchor up-current of the spot, set some chum blocks out the back of the boat and put one bait on the bottom and one on top. It shouldn't take long for you to get a bite.

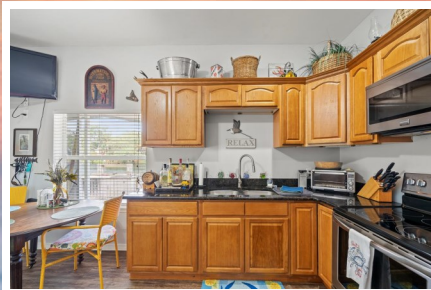






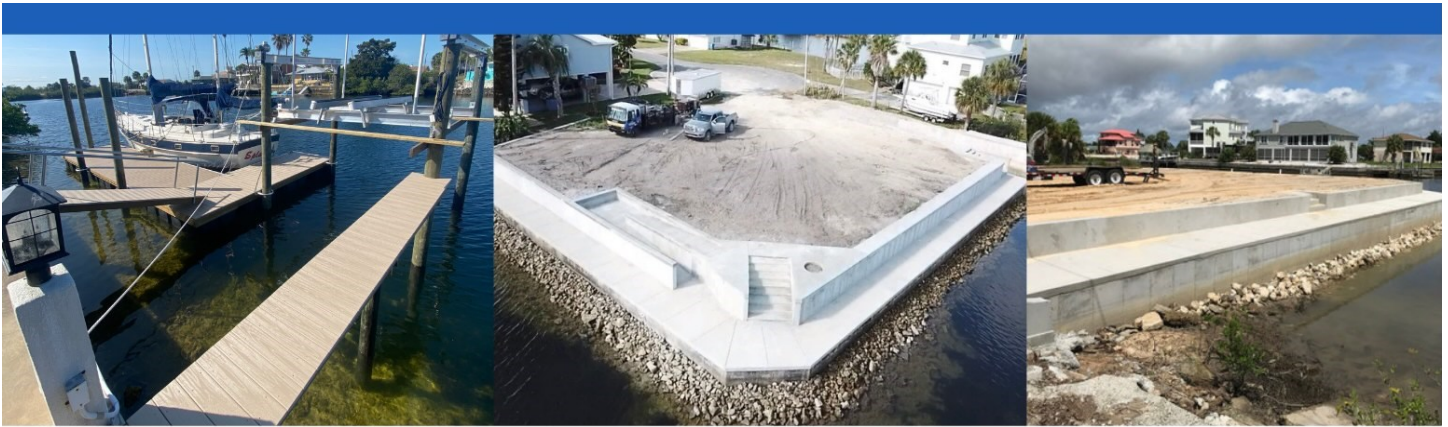

## NEW STATUE TRAIL CELEBRATES WEEKI WACHEE SPRINGS'S 75<sup>TH</sup> ANNIVERSARY ON FLORIDA'S ADVENTURE COAST

On October 13, 1947, Newton Perry opened the doors for the first show at Weeki Wachee Springs, featuring an underwater theatre.

Seventy-five years later, the park has become an iconic symbol of Florida, whose mermaids captivate audiences all over the world. During its heyday in the 1960s, the glamorous mermaids performed eight shows a day to sold-out crowds and would attract guests like Elvis Presley, Don Knotts, Esther Williams, and Arthur Godfrey.

Each of these life-sized mermaid statues will be painted by juried artists, to be unveiled in Weeki Wachee Springs State Park for the Anniversary Celebration beginning October 13, 2022. After the celebration, they'll be moved to their permanent locations throughout Florida's Adventure Coast, Brooksville – Weeki Wachee.

## HURRICANE HAZARDS

While hurricanes pose the greatest threat to life and property, tropical storms and depression also can be devastating. The primary hazards from tropical cyclones (which include tropical depressions, tropical storms, and hurricanes) are storm surge flooding, inland flooding from heavy rains, destructive winds, tornadoes, and high surf and rip currents.

- Storm surge is the abnormal rise of water generated by a storm's winds. This hazard is historically the leading cause of hurricane related deaths in the United States. Storm surge and large battering waves can result in large loss of life and cause massive destruction along the coast.
- Storm surge can travel several miles inland, especially along bays, rivers, and estuaries.
- Flooding from heavy rains is the second leading cause of fatalities from landfalling tropical cyclones. Widespread torrential rains associated with these storms often cause flooding hundreds of miles inland. This flooding can persist for several days after a storm has dissipated.

- Winds from a hurricane can destroy buildings and manufactured homes. Signs, roofing material, and other items left outside can become flying missiles during hurricanes.
- Tornadoes can accompany landfalling tropical cyclones. These tornadoes typically occur in rain bands well away from the center of the storm.
- Dangerous waves produced by a tropical cyclone's strong winds can pose a significant hazard to coastal residents and mariners. These waves can cause deadly rip currents, significant beach erosion, and damage to structures along the coastline, even when the storm is more than a 1,000 miles offshore.

## HURRICANE SAFETY

### BEFORE A HURRICANE

- Know your zone: Do you live near the Gulf or Atlantic Coasts? Find out if you live in a hurricane evacuation area by contacting your local government/emergency management office.
- Have a Family Emergency Plan: Before an emergency happens, sit down with your family or close friends and decide how you will get in contact with each other, where you will go and what you will do in

an emergency. Keep a copy of this plan in your emergency supplies kit or another safe place where you can access it in the event of a disaster.

- Put Together an Emergency Supplies Kit: Put together a basic disaster supplies kit and consider storage locations for different situations. Check emergency equipment, such as flashlights, generators and storm shutters. For a list of key items for your kit, see [www.ready.gov/kit](http://www.ready.gov/kit)
- Review Your Homeowners Insurance: Review your insurance policy to ensure that you have adequate coverage for your home.
- Understand NWS forecast products, especially the meaning of NWS watches and warnings.

### DURING A HURRICANE

- Secure your home: Cover all of your home's windows. Permanent storm shutters offer the best protection for windows. A second option is to board up windows with 5/8 inch exterior grade or marine plywood, built to fit and ready to install. Buy supplies before the hurricane season rather than waiting for the pre-storm rush.
- Stayed tuned in: Check the websites of your local National Weather Service office and local government/emergency management office. Find out what type of emergencies could occur and how you should

respond. Listen to NOAA Weather Radio or other radio or TV stations for the latest storm news.

- Follow instructions issued by local officials. Leave immediately if ordered!

#### IF NOT ORDERED TO EVACUATE:

- Take refuge in a small interior room, closet or hallway on the lowest level during the storm. Put as many walls between you and the outside as you can.
- Stay away from windows, skylights and glass doors.
- If the eye of the storm passes over your area, there will be a short period of calm, but at the other side of the eye, the wind speed rapidly increases to hurricane-force winds coming from the opposite direction.

#### AFTER A HURRICANE

- Stay Informed: Continue listening to a NOAA Weather Radio or the local news for the latest updates. If you evacuated, return home only when officials say it is safe.
- Stay Alert: Drive only if necessary and avoid flooded roads and washed-out bridges. If you

must go out, watch for fallen objects in the road, downed electrical wires, and weakened walls, bridges, roads and sidewalks that might collapse.

- Assess the Damage: Walk carefully around the outside of your home to check for loose power lines, gas leaks and structural damage.

### STAY SAFE:

- Stay out of any building if you smell gas, if floodwaters remain around the building or if the building or home was damaged by fire and the

authorities have not declared it safe.

- Carbon monoxide poisoning is one of the leading causes of death after storms in areas dealing with power outages. Never use a portable generator inside your home or garage.
- Use battery-powered flashlights. Do NOT use candles. Turn on your flashlight before entering a vacated building. The battery could produce a spark that could ignite leaking gas, if present.

## 2022 GULF RECREATIONAL RED SNAPPER

- Florida's 2022 recreational red snapper season will open June 17 and run consecutively through July 31.
- The season will reopen in the fall for the following weekends: Oct. 8-9 (Sat. & Sun) Oct. 15-16 (Sat. & Sun) Oct. 22-23 (Sat. & Sun) Nov. 11-13 (Fri., Sat. & Sun - Veterans Day weekend) Nov. 25-27 (Fri., Sat. & Sun - Thanksgiving weekend)
- This season applies to recreational anglers fishing from private vessels in Florida Gulf state and federal waters. For-hire operations that do not have a federal reef fish permit may also participate in the season but are limited to fishing for red snapper in Florida Gulf state waters only.
- Florida was required to reduce the 2022 quota by 13% to payback 2021 overages. The current 2022 quota is 1,167,163 lbs.
- Descending device or venting tool must be rigged and ready to use on trips in Gulf federal waters targeting reef fish

### State Reef Fish Survey

All anglers on the Atlantic and Gulf coasts of Florida who intend to fish for or harvest certain reef fish from a private vessel are required to obtain the State Reef Fish Angler designation.
