- Clinton County has proposed a zoning ordinance amendment No. OR-152-19, Recreational Marihuana Establishments Prohibition. This amendment states that the eleven townships within Clinton County that do not have their own zoning boards have opted out of allowing marihuana establishments within their townships.
- Kelby Leiby, Maple Rapids Fire Department Chief, submitted a wish list of items the fire department would like to purchase if funds are available.
