## CONSIGNMENT AGREEMENT

This agreement is being made between **BuckBass, LLC** and you, the **Consignor**. BuckBass, LLC operates a retail store and agrees to make its best effort to sell the Consignor's goods. This agreement can be terminated by BuckBass, LLC or the Consignor at any time as long as the Consignor's item has not been sold.

Consignor has turned over the items described on page 2, to BuckBass, LLC, which shall remain property of the Consignor until the listed items are sold within the length of consignment terms.

BuckBass, LLC length of consignment is 60 days from the day you bring your item(s) in. After 30 days we will reduce the selling price by 25%. After the 60<sup>th</sup> day you will need to pick up your items or re-consign them. If you do not pick up your item(s) or re-consign them by the 63<sup>rd</sup> day, **your items will become property of BuckBass, LLC.**

BuckBass, LLC, at its discretion, may decline items or opt to return unsold goods to consignor at any time. Consignors items must be clean and in ready to use or wear condition when brought in to be consigned.

BuckBass, LLC agrees to return to consignor, upon demand, any of his or her unsold merchandise within the agreed upon 60 day consignment term. The goods must be returned to the consignor in the same or similar condition as they were dropped off, unless this is impossible due to shopper damage or theft.

**BuckBass, LLC is not responsible** and will not be held liable for lost, damaged, or stolen items. You the consignor are leaving your items at your own risk. BuckBass, LLC will do its best to protect your items.

**The consignor's items will be priced at the discretion of BuckBass, LLC.** Once the item is sold BuckBass, LLC will receive 50% commission of the final sale price and the consignor will receive 50% of the final sale price.

Consignor agrees that all proceeds due from the sale of the consignor's items, **minus 50% commission,** will be available to consignor as outlined below under "PAYMENT".

### **PAYMENT**

Payment to Consignor for items sold will be made by check only, NO EXCEPTIONS. Checks will be mailed to consignor for amounts over \$20.00 at the beginning of each month. Checks will be for the items sold the previous month (i.e. Items sold in the month of January will be paid out in February). If your items sold do not exceed the amount of \$20.00 you may pick up your payment in the store between regular business hours.
