ALABAMA

Alabama originally was part of the Mississippi Territory. It became a territory in its own right in 1817, followed by statehood two years later. Initially a single district state, Alabama was divided into the Northern and Southern Districts in 1824, but the same judge presided over both districts.¹ The Middle District followed in 1839, again with only one judge for all three districts.²

AL.MD.01 is the original judgeship which–prior to the addition of a second seat in 1886–first served the entire state, then two and then all three of the state's districts. The 1886 seat being for the Southern District,³ AL.MD.01 retained jurisdiction over the Middle and Northern Districts until 1936, when it was assigned exclusively to the Middle District.⁴ AL.SD.02 was created in 1966 to serve both the Middle and Southern Districts⁵ until an additional judgeship was authorized for the Middle District four years later.⁶

AL.ND.02 was legislated in 1938 as a temporary slot, with the provision that the next vacancy on this court would not be filled. When Judge Davis died later in that same year, AL.ND.01 ended and AL.ND.02 continued as a permanent line. AL.ND.09 also was created as a temporary position in 1990, but it was not converted and as a consequence Judge Acker's line (AL.ND.03.04) ended, as mandated by the 1995 act.⁷ AL.ND.10 was also created as a temporary position,⁸ stipulating that the first vacancy occurring on the court 10 or more years after the confirmation of the Judge Proctor would not be filled.

With the reorganization of the Fifth Circuit in 1980,9 Alabama joined Florida and Georgia in the
