Preparations for FABA Chicago's Winter League 2016-2017, which is tentatively scheduled to start in November 13, 2016 is now in full swing, and we would like to take this opportunity to present exciting promotional opportunities for your company. The league will run approximately 19 weeks. We offer the following advertising opportunities:

1. Team Sponsors: \$375.00

- a. Your company name and logo will be printed on the team uniform and jackets of each player of the team representing your company.
- b. Sponsors or team representatives will be allowed to select six (6) players of their choice, two of whom may be non-Filipino. Non-Filipino players are subject to approval by FABA Chicago. Filipino players are defined as full blooded Filipinos, Filipino Americans and Filipino mixed other than American who are able to show proof such as birth certificate. If quarter blood (Filipino grandparents), proof of original ethnicity must be presented. If you have non-Filipino players on your roster, the maximum height of the first should not be more than 6'5' and 6' and under for the second.
- c. Each team player will pay \$140.00 registration fee, and that will include their uniforms, jackets, facility fees, referee fees and accident insurance.
- d. If you do not wish to recruit your own players, FABA Chicago will assign players on your team.
- e. Team sponsors' company name and logo, including their address and phone number, and a link to their company website will also be included on FABA Chicago's official website. For website inclusion, we will need a business card size AD (Color) in jpeg format.
- f. Team Sponsors are required to submit a high resolution (300dpi) jpeg version of their company logo as soon as possible.
- g. Team sponsors are on a first come first served basis only. Since we need to order the uniforms already, and we need your confirmation ASAP.
