To Hold a Puppy until Puppy Reaches Age Ready for Pickup

If the puppy is not paid for in full (including the rest of the purchase **Balance Due:** _____ **owed**) by the time puppy reaches 8 weeks of age, deposit price will be forfeited and is **NON REFUNDABLE** if you should decide that you no longer wants the puppy chosen to put deposit on. By placing a deposit you agree to pay the balance by the time the puppy reaches 8 weeks of age.

The only reason deposit price would be refunded to buyer, would be in the event that the puppy should become too sick to sale or should die. Should this event happen, buyer would have the choice of a monetary refund or choosing another puppy, if one is available.

The Seller reserves the right to void this transaction and refund the deposit if we learn of any reason why Buyer might not be suitable for the puppy –(i.e. Buyer is found to be an animal abuser, violent person, representative of a Pet Store, representative of a pharmaceutical research laboratory etc.) .
