Minutes of the Board of Directors of the Humboldt Lodging Alliance, meeting Tuesday, April 24, 2018 at the Red Lion Hotel, Eureka, California.

The meeting was called to order at 12:00 pm by chair Chris Ambrosini. He confirmed that a quorum of board members was present.

The agenda for April 24, 2018 was approved with the following change: Remove item #9, a report on Cannabis tourism research (Porter/Hufford/unanimous).

The minutes of the January, 2018 board meeting were approved (Stone/Daniels/passed).

Zach Winger was appointed to the board to fill the seat vacated by Diane Cutshall in Arcata. (Daniels/Porter/unanimous) Mike Reinman said that he would like to see the 80 vacation rentals in Arcata represented.

Humboldt/Del Norte film commissioner Cassandra Hesseltine made a presentation and annual funding request. Her Powerpoint detailed local spending by film productions and the multiplier effect. She had attended the Sundance Film Festival and connected with a producer about filming an episodic show in Humboldt County. Chris Ambrosini confirmed that the funding continued to support a full-time employee at the Film Commission. The board approved funding of \$60,000 for fiscal year 2018-2019 (Porter/Rowley/unanimous).

Next, Aaron Ostrom and Jonathan Jones of Pacific Outfitters presented about their booking program for guided activities that hotels can bundle with lodgings. Questions and issues included:

- Hotels must be named as additional insureds.
- Must offer flexible party sizes.
- Needs two day lead time.
- Guests can be completely outfitted for fishing and hunting.
- Promo codes will be provided to lodgings.

Next, Matt Kolbert of the Misfit Agency game a campaign progress report:

- There were two flights of television ads this year.
- As usual, a lot of value added (free) advertising was obtained.
- Facebook advertising launched using the profiles from the visitor bureau's Facebook followers
- A "featurette" video for Northern Humboldt was upcoming.

Next, the board received a report of Executive Committee actions since January.

The financial statement for March, 2018 was examined and approved (Porter/Reinman/unanimous).

Under Director Reports, John Porter announced that the Benbow Inn was named "Best of local B&Bs and Inns" in the Times-Standard readers poll. Chris Ambrosini reported that legal counsel was being retained to guide the HLA grants for Sequoia Park & Zoo.
