**While there is no entrance fee for shoppers to attend the event, attendees will be more likely to be active shoppers rather than general foot traffic from a street event because this event is being held at a private location that patrons must drive to.*

Food Booth Vendor:

- Must provide your own **fire retardant tent/canopy** if cooking with open flame.
- Must provide protection material under cooking area.
- Gas hookup will be completed at approximately 7:30AM Sunday.
- Food Booth must use only approved propane gas containers.
- City Inspections will be done on ALL vendors using gas.
- **Must provide proof of current liability insurance, adding GFWC NPWC and St. Petersburg College (Clearwater Campus) as additional insured.**
- Minimum pricing for vendors selling water is \$2.00
- Minimum pricing for vendors selling soda is \$3.00

Food Truck Vendor:

- Must be self-contained (to include water, propane, and electricity).
- Must have current food truck sticker (photo/copy must accompany application) from City of Clearwater.
- Fire Marshal inspections to verify sticker expiration date will be done on all Food Trucks at approximately 8AM Sunday.
- **Must provide proof of current liability insurance, adding GFWC NPWC and St. Petersburg College (Clearwater Campus) as additional insured.**
- Minimum pricing for vendors selling water is \$2.00
- Minimum pricing for vendors selling soda is \$3.00

To Apply:

- Fully read the application packet.
- Complete the entire application, including designating Food Vendor Type and Entrance Time requests.
- Sign the application on page 4.
- Sign the waiver line at the bottom of page 4 of the application to take advantage of our free publicity. We plan to use your emailed photographs for promotional purposes on our Facebook pages.
- Review and sign the Rules & Regulations on page 5.
- Attach food truck sticker number and at least one photo of your food booth / truck.

Exhibitor Rules and Regulations

1. Vehicle entry for booth set up will be permitted Sunday morning. Vehicles must be removed from show grounds by 8:00 AM on Sunday. If your Truck or Booth space is not occupied and set up for fire marshal inspection by 8:00 AM, you will not be permitted to participate in the show. No refund will be given.
2. Should you offer any items different from the items stated in your application which were not approved during the application process, you may be requested to remove such items or be subject to expulsion from the event and no refund shall be given.
3. If you require electricity, quiet generators are recommended and permitted, so long as they do not disturb other exhibitors.
4. Breakdown is not permitted to start until 4:00 p.m. and must be completed by 6:00 p.m. All exhibitors must be vacated from the campus by 6:00 p.m.
5. Due to St. Petersburg College regulations, ALL exhibitors will be required to transport ALL their items from the parking lot – canopies/booth set up equipment/wares/etc.
6. There will be NO staking of any kind. Canopies will need to be secured by other means.
7. The number of exhibitors with like or similar works will be limited.
8. You should receive a confirmation of your acceptance no later than August 15, 2018, after which you will have ten (10) days to submit payment. Failure to do so will result in you forfeiting your booth space.
9. Online payment is now an option. You will be provided with instructions upon acceptance. A \$35.00 bank fee will be charged on all returned checks. The check amount plus \$35.00 shall be thereafter payable with a money order or cashier's check to secure your acceptance.
10. You will be responsible for researching, collecting and reporting all applicable local and state sales taxes to the appropriate department of revenue. Out of state exhibitors must also adhere to their individual state laws.
11. Due to campus restrictions and insurance liabilities, no animals or pets are permitted on show grounds, except designated service animals assisting persons with disabilities. No therapeutic animals shall be permitted in the event.
12. Due to campus restrictions and insurance liabilities, no alcoholic beverages may be brought into the show grounds.
13. The GFWC North Pinellas Woman's Club, Inc., St. Petersburg College, their representatives and committees reserve the right, at their sole discretion, to require an exhibitor to withdraw from the show. Exhibitor shall have no recourse nor shall the GFWC North Pinellas Woman's Club, Inc. be liable in any way for any indirect, direct, consequential, lost profits, or any other damages that may be incurred by the exhibitor.
14. Because the GFWC North Pinellas Woman's Club Holiday Market is held outdoors, GFWC NPWC, St. Petersburg College, their representatives and committees cannot be responsible for weather, ground conditions, or other factors beyond our control. Booth spaces will be on grass and may have uneven areas. Rain, wind, and other weather conditions may be present. We will do our best to accommodate all exhibitors and their needs, and we request that exhibitors remain considerate of their customers, fellow exhibitors, and the volunteer staff organizing and running the show.
