

6/10/2019

Deputy Copley attempted to catch up to a reckless driver North of Clarington on State Route 7. The vehicle made it out of our county, but Powhatan PD stopped the car.

Sgt. Norman and Deputy Harr responded to State Route 800 near State Route 255 in an attempt to locate an injured deer. The animal was GOA.

Deputy Schuerman responded to the call of a disabled vehicle blocking the roadway on Township Road 470 off Dent Ridge Road. Contact was made and Stephens Towing removed the vehicle from the roadway.
