## Isy's Ways

### Release and Waiver of Liability

I understand that my participation in any of Isy's Ways training classes or private training (hereby referred to as training) includes an element of risk for me, attending family members/guests and my dog, which includes, without limitation, risk of illness, falls, bites and injury through contact with other people or dogs who may or may not be participants in training, or interior/exterior surroundings of any facility or public place where training takes place. I understand that participation in training by me, attending family members/guests, and my dog is voluntary. I understand that participation in the training at Isy's Ways is not without some risk to myself, members of my family/guests who may attend, or my dog; that despite all the dogs appearing healthy and being handled with the greatest amount of care and foresight, dogs are not always predictable and that the unexpected may occur. I hereby waive and release Isy's Ways, its employees, volunteers, owners and agents from any and all claims while on the grounds or surrounding areas thereto, and resulting from participation in training at Isy's Ways. Including specifically, but without limitations, any injury or damage resulting from the action of any dog, including my own. I, and attending family members/guests, and on behalf of their respective heirs, assigns or successors, hereby expressly waives, releases and discharges Isaac Terrell dba Isy's Ways from and claims, demands, injuries, damages or causes of action that are in any way related to participation in the training, even though such liability may arise out of negligence or carelessness on the part of the persons named in this Waiver and Release. I am willing to accept assumptions of the risk of participation in training and the risk of illness, bodily injury, death or property damage while under the supervision of Isy's Ways in my own home or a public space.

Isaac Terrell dba Isy's Ways make no representations, guarantees, promises, implied or expressed, that any training received from Isaac Terrell dba Isy's Ways will cure a dog of any dangerous propensities. It is fully understood that regardless of the training received by the animal, any dog is always capable of biting. I hereby agree to indemnify and hold harmless Isaac Terrell dba Isy's Ways from any and all claims, or claims by any member of my family or any other person while on the grounds of any facility where training takes place, the surrounding area thereto, on my own property, or in a public area as a result of any action by any dog, including my own. I expressly agree that the foregoing release and waiver, and assumption of risk are intended to be as expansive, broad and inclusive as permitted by Virginia law.

I affirm and have proof that my dog is current on all vaccinations appropriate to my dog. I agree to abide by all rules presented during the training. Refunds of training fees will be given only at the discretion of the trainer, and I understand that I may be charged for training if I give less than a 24-hour notice for cancellation. I also understand that Isaac Terrell dba Isy's Ways may use for publicity pictures or videos of my dog or me for promotional purposes without liability or obligation to me.

**Further, by signing below I understand that, there is an inherent risk of illness, injury, disease, or death due to exposure to other dogs and elements of any public facility. Dogs and puppies should be vaccinated per Virginia law. Vaccinations should be administered on the schedule recommended by your veterinarian. I understand that I am participating in training with full knowledge of risk and agree to indemnify and hold harmless Isaac Terrell dba Isy's Ways as well as any facility or owner of a facility where classes are held. The risk is mine and only mine, and I understand that I am taking full responsibility for said risk.**
