WATER/SEWER

MDA provided a report and an update was given by Caleb Henning on the DWSRF project. Don McElwain stated that the Sewer had received a surprise DEC inspection.

<u>CLERK</u>

Clerk Hind submitted the monthly report for October 2017 to the Board. The local shares were \$510.18 to the Supervisor and \$3117.18 to the Town. She also stated that the reimbursement forms had been submitted for CHIPS, EWR and PAVE NY to the State DOT. The two FEMA projects have also been submitted for reimbursement for \$467,174.39. A DAR Representative will be contacting Clerk Hind for a meeting regarding the submittal.

A report was supplied to the Board on the activities for the month of October 2017. Sickles asked when the corner of Larkin and Messinger would be repaired from the DWSRF project work. Caleb Henning and Dave Fischer stated the contractor would be back to make the repairs.
