X. STAFF REPORTS

Planning and Development Services staff member Sue Farnsworth apprised council on the county ordinance for adult internet arcades. She stated the ordinance is not final, but it is in the works.

Commissioner Miller and Lt. Cassidy apprised council on the adult internet arcades and issues that EMS, Fire and Police have been having with the arcades. They suggested a 10 pm curfew for these types of business. They stated the curfew has helped keep emergency service calls to a minimum. They stated the 10 pm curfew has been very effective in other cities, and suggested we follow suit.

City Manager Naugler stated the city would like to build their own sewer plant. The city has set up an account to save and allocate money for a sewer plant. The ARP funds received will go into this account.

Mayor Pro-Tem Malott stated the portalet at Sam Harris Park does not lock and needs to be cleaned. Mayor Pro-Tem Malott asked if it was possible if Dust Above cleaning could also clean the city park bathrooms, and if that could be added into the contract.
