**Old Business:**

1) An update on the 60<sup>th</sup> street bridge project was given, and the install timeline was given. The project is slated to start the end of October. Debbie Uecker will reach out to resident Harlan Poppler to make him aware of the timeline.

2) Concerns were raised over the Wright County unfished road project on County Road 9.

**New Business:**

1) Joel & Beth Ebert of 5725 Endicott Ave were present to discuss the Township road washing into their driveway. The Ebert's presented pictures of the current rain fall and are looking for a solution to keep the gravel on the road. Augie Riebel and the road maintenance employees will do a site inspection and see if we can shape the road/grade of the road to keep the water off the road.

2) Having heard no complaints regarding Jim Gravelle/Sharron Rackliffe CUP to locate a radio-controlled model airport flying field and club center. A motion was made to renew the CUP for Jim Gravelle/Sharron Rackliffe under the same conditions for review in 2 years was made by Augie Riebel, 2<sup>nd</sup> by Jane Hurley and carried 3-0.

**Business from the Floor:**

1) Maintenance was discussed on the 1995 Ford Truck; the box is rusted thru and it will need to be replaced. We are looking to replace the box with a new box ranging between \$17,000 to \$18,000. We looked at used boxes and they are very well used. A motion was made by Joe Hickman, 2<sup>nd</sup> by Jane Hurley to pursue a new box for fit the 1995 Ford Truck with the angles, truck and sander and carried 3-0.
