



## Dura Coat Products Inc. XT-40 Super Durable Coatings 40 Year Limited Warranty

Dura Coat Products, Inc. provides the following warranty concerning the use of Dura Coat's **XT-40 Super Durable Coating** Systems for roofing and sidewall applications:

- Dura Coat Products, Inc. (Dura Coat) warrants that the XT-40 Super Durable SMP Coating Systems, including
  primer and backer, when applied over prime properly cleaned and chemically treated Aluminum, Hot Dipped
  Galvanized Steel (G-90), and Aluminum/Zinc coated steel in accordance with Dura Coat Products Inc.
  application and product data sheets, will not under normal atmospheric conditions:
  - A. Chip, Crack, Check, or Peel for a period of (40) forty years from date of installation (except for such crazing that may occur on tightly roll-formed edges and brake bends).
  - B. Chalk in excess of a numerical rating of (8) for a period of (30) thirty years from date of installation when measured in accordance with the standard procedures outlined in ASTM D-659 on vertical (sidewall). On horizontal application (roofing), chalk will not exceed a-numerical rating of (6).
  - C. Fade or change color in excess of (5) E units for a period of (30) thirty years from date of installation on vertical (sidewall) and (7) E units for horizontal (roofing) application when calculated in accordance with ASTM D-2244. The color change is to be measured on exposed painted surface cleaned of surface soils and oxidation. In addition, labor costs to re-coat a field failure will be included.
  - D. Coverage is warranted against red rust for a period of ten (10) years, no greater than one half inch from cut edge (1/2 inch) provided that the prime substrate is properly cleaned and treated prior to the application of Dura Coat Products Universal Primer (DC477) and XT-40 Ceranamel Topcoat.
- This warranty is restricted to failures resulting from normal weathering and does not include coating failures caused by scratches, scrapes or any other unnatural damage including improperly formed, fabricated or embossed material. Dura Coat accepts no hability for damages caused by acts of God, radiation, falling objects, explosions, or other external forces beyond Dura Coat's control.
- This warranty excludes failures caused by standing water, and direct exposure to corrosive and aggressive atmospheres including animal waste products and applications exposed to salt spray or within 1500 feet of the seacoast.
- It is recommended that the building be maintained by washing with fresh water with a mild detergent at least biannually.
- 5. Dura Coat's responsibility extends only to the direct cost of refinishing or replacing falled coated substrate. . Dura Coat can not accept liability for loss or damage to other property or equipment, loss of profits or sales, or any other claims relative to standard business interruption, or any other incidental or consequential damages.
- 6. Dura Coat reserves the right to establish whether repainting or replacing material is required and to approve and participate in the negotiation of any subcontracted material replacement, installation, or refinishing. After replacement or re-finishing of the repaired area, this area will be considered as installed as of the original installation date for the purpose of the application of this warranty.
- 7. Claims under this warranty must be submitted in writing within forty-five (45) days of discovery of the warranted performance failure and Dura Coat requires the opportunity for site failure inspection and investigation. Dura Coat also reserves the right to solely evaluate and determine its obligation under the terms and conditions of this limited warranty.

- 8. The company seeking the warranty shall maintain, or have access to, adequate records to identify the coil coater, coil numbers, product identification and date of installation. Coatings shall be applied by approved applicators. In the event of a claim, Dura Coat reserves the right to inspect all records mentioned above.
- This limited warranty supersedes any and all other warranties of performance, expressed or implied, by Dura Coat. Any modifications, additions, or adjustments made to this warranty must be officially added as a signed written amendment.
- 10. This limited warranty is nontransferable and non-assignable and may not be modified, extended, or enlarged by any representative of Dura Coat or intermediate salesman or agent.
- 11. This limited warranty shall be governed by and interpreted in accordance with, the laws of the State of California.
