<u>Cathedral Donation & Pay to Bus Drivers</u>: We donate annually in addition to what we receive at convention. Mass collection was \$882. It was agreed that we will not do an annual donation to the cathedral at this time.

Every year we wait to see our profit from convention to know what to pay the drivers.

Becky Hicks moved that we pay Judge Memorial Drivers \$500. Motion passed.

<u>A/V coordinator</u>: We need an Audio-Visual coordinator to coordinate ZOOM Meetings. Because we may not be able to attend meetings in person, is there anyone to do AV for us? The cost is \$15

month for unlimited time. If 'in person' and zoom it is hard for the director (president) to do both. An Ad Hoc committee formed to do Zoom. Becky Colombo volunteered.

<u>2022-2023 DCCW Calendar:</u> November 19: Salt Lake Deanery (need a host parish); January 28 Wasatch Deanery – St. Mary's

<u>Gail's travel fee as speaker</u>. Gaylel Kasenhas asked for reimbursement of her travel fees. Just registration and flight. Not speaker fee. She asked for flight only. \$337. Michael O'Shea motion; 2nd Stacy Oliveto. Passed. We will reimburse Gayle the \$337. Becky Colombo has her receipts.

<u>Convention 2023</u>: Becky Hicks. Room Rates are probably going to go up. Little America has guaranteed \$149/night but can only go to 800 people to accommodate; can guarantee a plated dinner & lunch. Sheraton capped at 500. If we stay at Sheraton, we need to throw more \$ to food. Little America wants a tentative contract within the next 45 days. Finance committee will help make the decision,
