Mike Theisen gave the September Fire and EMS reports.

Mike asked about going to bi-weekly pay and direct deposit. The fiscal officer will check into it.

Bruce Lane gave an update on the new township building saying the electrician came and laid everything out where it needs to go and said he would be having someone help him, but has not been back and isn't returning phone calls or texts. Bruce said he is going to look into getting someone else to finish the job.

Trustees and Charlie Montgomery talked about the problems with the electrician and discussed vehicle issues and things that need replaced.

2nd by Jean Morrison. Roll call: Jean Morrison -yes, Bruce Lane -abstain, Randal Almendinger -yes. Motion carried.

Bruce Lane made a motion to approve Jean Morrison up to \$3000.00 to purchase storage shelves to keep township records on at the fire station.

2nd by Randal Almendinger. Roll call: Jean Morrison -abstain, Bruce Lane -yes, Randal Almendinger -yes. Motion carried.

Randal Almendinger said we received 16 resumes on Indeed for the road maintenance position. Trustees talked about CenturyLink not burying their lines or marking them properly. Checks were signed.

Randal Almendinger made a motion to go into executive session to discuss personnel issues, being the resumes received with the fiscal officer, trustees, and Charlie Montgomery.

2nd by Jean Morrison. Roll call: Jean Morrison -yes, Bruce Lane -yes, Randal Almendinger -yes. Motion carried.

Jean Morrison made a motion to adjourn executive session and return to open session.

2nd by Bruce Lane. Roll call: Jean Morrison- yes, Bruce Lane -yes, Randal Almendinger -yes. Motion carried.

Randal Almendinger said the results of the executive session were 3 individuals were chosen to interview being: Bill Knipp, Roy Wengert and David Sapp.

Bruce Lane made a motion to hold a special meeting on Tuesday, October 19, 2021 at 6:00 to conduct interviews for the road maintenance position at the St. Albans Township Fire Station.

2nd by Randal Almendinger. Roll call: Jean Morrison -yes, Bruce Lane -yes, Randal Almendinger -yes. Motion carried.
