- 2. The annual meeting time and date will be set by the board. We will no longer be forced to hold the meeting when most people are at work. Hopefully, this will give us a higher attendance at future meetings.
- 3. When you sell your unit, the new buyer will be required to pay 3 months maintenance fees. This money will go directly into the reserve account. This is to help offset future increases in maintenance fees.

The current Pinnacle Gardens Board of Directors has struggled to find a fair way to structure the operational and reserve budget so as not to place undue financial pressure on current and/or future residents, while still providing adequate funding to insure that all obligations set forth in the controlling documents are met.

A major step was taken with the commission of the Reserve Study in 2012. As a result, a plan was initiated to stabilize monthly fees, provide adequate reserve contributions, and hopefully eliminate the need for future assessments. It is the guideline to provide for future repairs and upkeep and can only be effective if everyone is current with monthly dues and delinquent accounts are brought up to date.

The BOD would like to remind all residents that involvement in the current and future operations of this community is welcomed and vital to insure the association's success. The association meeting on the second Monday of each month affords all residents a time and place to make suggestions, recommendations or freely air complaints which you may have. We welcome your participation.

With the adoption of the 2012 proposals, including the reserve study, the future of the Pinnacle Gardens Association and the ability to continue to rebuild value lost during the 'housing crash' has been greatly improved and will aid greatly in providing each of us with a financially stable community in which we can all be proud.
