Supervisor discussed use of ARPA funds for broadband, refer to map and cost attached from Midwest Energy & Communications.

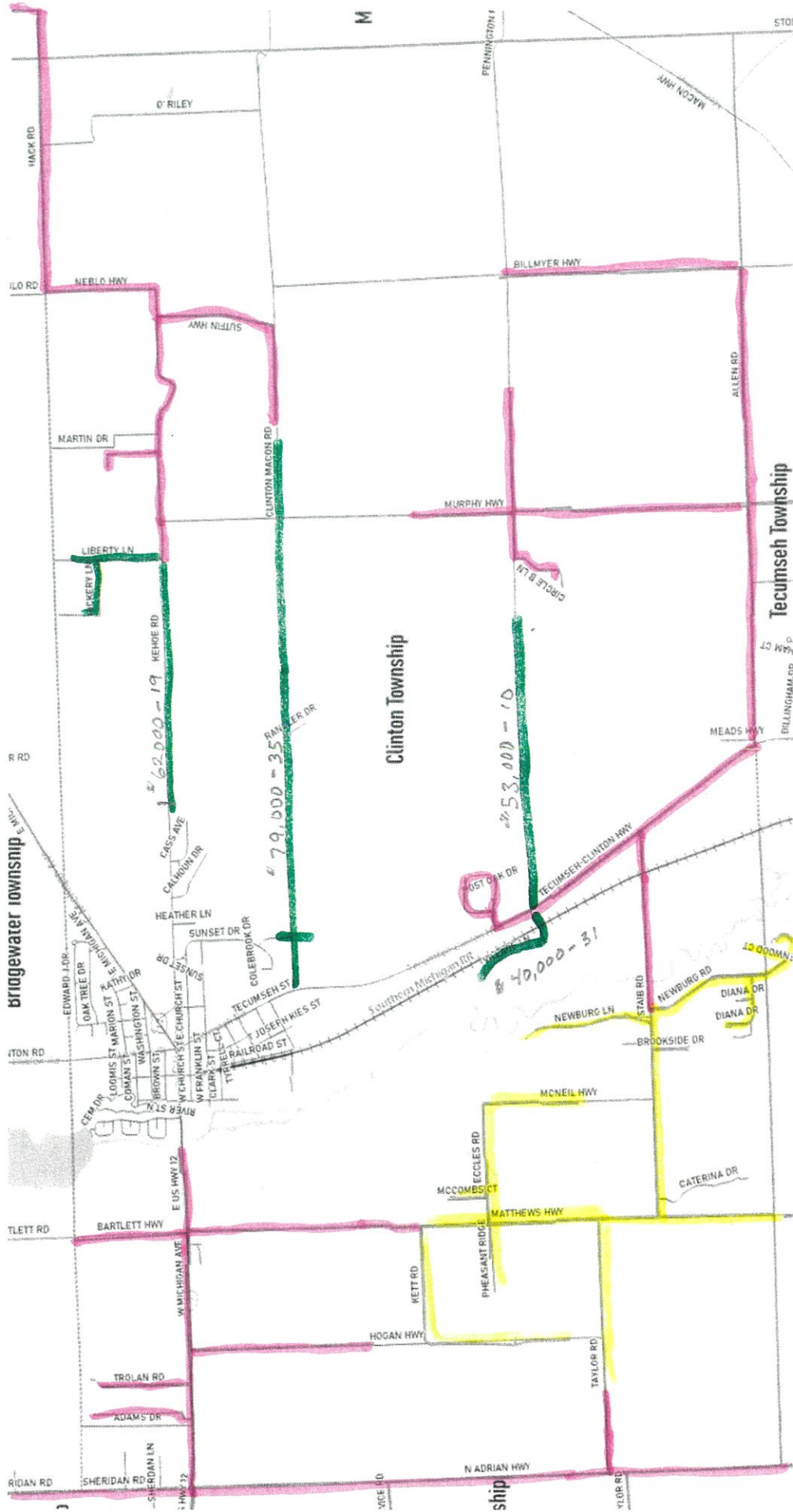
