

ORDINANCE # 331

AN ORDINANCE AMENDING SECTION 6 OF ORDINANCE # 317, REGULATING THE SALE OF ALCOHOLIC BEVERAGES IN THE CITY OF ROLLA, NORTH DAKOTA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROLLA, NORTH DAKOTA:

SECTION 1. THAT SECTION 6 OF ORDINANCE # 317 BE AND THE SAME HEREBY IS AMENDED TO READ AS FOLLOWS:

SECTION 6. LICENSES TO BE ISSUED.

Licenses for the sale of beer, wine, and/or alcoholic beverages at retail as provided in this ordinance shall consist of seven kinds, to-wit:

- (1) On-sale licenses,
- (2) Off-sale licenses,
- (3) On-sale dining room-lounge licenses,
- (4) On-sale draught beer licenses,
- (5) Specialty restaurant licenses,
- (6) Fred C. Wagner American Legion Post special license,
- (7) Rolla Curling Club special license,
- (8) Temporary license

(G) The Fred C. Wagner American Legion Post special license is a special on-sale only license which can be issued only to Fred C. Wagner American Legion Post of Rolla. It is not transferable or assignable. This license permits the licensee to sell alcoholic beverages at Legion meetings and at other times when the Legion leases the licensed premises for wedding parties, Chamber of Commerce meetings, and other such special events for which the licensed premises is being used. This license permits the licensee to sell alcoholic beverages after the hour of 5:00 o'clock P.M. except when there is a special event being held on the premises, and during those special events alcoholic beverages may be sold after the hour of 8:00 o'clock A.M. as permitted by this ordinance and the laws of the State of North Dakota.

(H) The Rolla Curling Club special license is a special on-sale only license which can be issued only to the Rolla Curling Club. It is not transferable or assignable. This license permits the licensee to sell alcoholic beverages after the hour of 5:00 o'clock P.M. on any night of league curling, individual curling, or curling club meetings. When a bonspiel is held, alcoholic beverages may be

sold after the hour of 8:00 a.m. as permitted by this ordinance and the laws of the State of North Dakota.

(I) The licenses issued and defined as Temporary Licenses may at the discretion of the City Council, acting through the duly appointed City Auditor and the Mayor, or president of the Council, be issued to any holder of a valid liquor license under Subsections 1, 2, 3, 4, 5, 6 and 7 above. The temporary license will be issued when a licensee wishes to cater the sale of alcoholic beverages at a function not occurring on his licensed premises. Such a temporary license shall be valid for the period of time stated on the license. The license is not valid unless it contains the signature of the auditor and mayor, or president of the City Council.

(J) License fees shall be as follows:

 2. Off-sale license \$1000.00
 3. On-sale dining room-lounge license \$1500.00
 4. On-sale draught beer license \$400.00
 5. Specialty restaurant license \$500.00
 6. Fred C. Wagner American Legion Post special license:
1) On sale \$200.00 or 2) Beer only \$50.00
 7. Rolla Curling Club special license: 1) On sale \$200.00 or 2) Beer only \$50.00
 8. Temporary license \$25.00

SECTION 2. AFFIRMATION. Ordinance # 317 and all amendments to that ordinance, not in conflict with this amendment, are hereby affirmed.

SECTION 3. EFFECTIVE DATE. This ordinance shall be in full force and effect and take effect immediately upon its final passage and approval.


